NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The State of Nevada, Department of Business and Industry, Division of Insurance (“Division”), (775) 687-0700, is proposing the adoption, amendment or repeal of regulations pertaining to **chapter(s) 616A, 683A, 686A, 689, 686B, 693A and 695C** of the Nevada Administrative Code (“NAC”). A workshop has been set for **1:30 p.m., on September 17, 2012**, at the Division’s office located at 1818 East College Parkway, 1st floor hearing room, Carson City, Nevada 89706. Interested parties may also participate through a simultaneous videoconference conducted at the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulation(s). Please submit any written comments no later than **September 10, 2012**.

LCB File No. R053-12. External Reviews and Reapproval Period/Fees.

A regulation relating to insurance; amending provisions relating to the external reviews of adverse determinations of certain health carriers; increasing the fee for reapproval of an independent review organization to conduct external reviews of adverse determinations; and providing other matters properly relating thereto.

LCB File No. R054-12. Statutory Reference for Broker/Agent.

A regulation relating to insurance brokers and agents; revising certain references to the terms “broker” and “agent” in provisions governing insurance trade practices; and providing other matters properly relating thereto.

LCB File No. R055-12. Repeal of Funeral Agent Examination.

A regulation relating to funeral services; repealing a provision requiring a certain minimum score to pass the examination for a license as an agent authorized to sell prepaid contracts for funeral services; and providing other matters properly relating thereto.

LCB File No. R102-12. HMO Schedules of Charges.

A regulation relating to insurance; repealing certain provisions concerning the schedules of charges of health maintenance organizations and provider-sponsored organizations; and providing other matters properly relating thereto.

LCB File No. R143-12. Penalties for Failure to File.

A regulation relating to insurance; revising an obsolete reference to Statutes of Nevada establishing the penalties for failure of an insurer to file certain financial and statistical information; and providing other matters properly relating thereto.

NOTICE OF INTENT TO ACT UPON REGULATION

Notice of Hearing for the Adoption, Amendment or Repeal of Regulations of The Department of Business and Industry, Division of Insurance

The State of Nevada Department of Business and Industry, Division of Insurance (“Division”), (775) 687-0700, will hold a public hearing at **1:30 p.m., on September 26, 2012**, at the Division’s office located at 1818 East College Parkway, 1st floor hearing room, Carson City, Nevada 89706. Interested persons may also participate through a simultaneous videoconference conducted at the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the adoption, amendment or repeal of the regulation(s) that pertains to **chapter(s) 686B** of the Nevada Administrative Code (“NAC”).

This proposed regulation is necessary to update a reference to statute. NAC 686B.395 refers to “section 7 of chapter 654, Statutes of Nevada 1987” (Act expired by limitation on June 30, 1989). The correct cite is NRS 679B.460 (Added to NRS by 1989, 1229).

- (2) What are the terms or substance of the proposed regulation?

The proposed regulation references penalties that may result if certain required information is not submitted by an insurer. This proposed regulation correctly references the same penalty referenced in 1987. The location of the citation changed in 1989.

It provides a correct and updated citation to statute. Penalties remain the same for not submitting certain required information.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal

reasons for and against its adoption, and incorporate therein its reason for overruling the consideration urged against its adoption.
