

**PROPOSED REGULATION OF THE  
BOARD OF MEDICAL EXAMINERS**

**LCB File No. R183-12**

**Notice of Workshops to Solicit Comments on Proposed Regulations**

The Nevada State Board of Medical Examiners, located at 1105 Terminal Way, Ste. 301, Reno, Nevada 89502, (775) 688-2559, is proposing the amendment of regulations pertaining to Chapter 630 of the Nevada Administrative Code. The public workshops have been set for 11:00 a.m., on January 29, 2013, at the Nevada State Board of Dental Examiners, located at 6010 S. Rainbow Blvd., Bldg. A., Ste. 1, Las Vegas, Nevada. The workshops will be videoconferenced to the conference room at the Nevada State Board of Medical Examiners at 1105 Terminal Way, Ste. 301, Reno, Nevada. The purpose of the workshops is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

- R182-12 1) Regulation relating to medicine; requiring a physician assistant to document certain information in a patient’s chart; requiring a collaborating physician to ensure that an advanced practitioner of nursing documents certain information in a patient’s chart; revising the number of physician assistants and advanced practitioners of nursing that a physician may simultaneously supervise or collaborate with.
  
- R183-12 2) Relating to physician assistants; amending the notification requirements for a physician assistant regarding any change in the supervision of the physician assistant by a supervising physician.

## NOTICE OF INTENT TO ACT UPON REGULATIONS

### Notice of Hearings for the Adoption/Amendment of Regulations of the Nevada State Board of Medical Examiners

The Nevada State Board of Medical Examiners will hold public hearings at 11:00 a.m., on Wednesday, February 13, 2013, at the office of the Nevada State Board of Medical Examiners located at 1105 Terminal Way, Ste. 301, Reno, Nevada. The public hearings will be videoconferenced to the conference room at the Nevada State Board of Medical Examiners/Dental Examiners located at 6010 S. Rainbow Blvd., Bldg. A, Ste. 1, Las Vegas, Nevada. The purpose of the hearings is to receive comments from all interested persons regarding the adoption of regulations that pertain to Chapter 630 of the Nevada Administrative Code.

- R182-12    1)    Regulation relating to medicine; requiring a physician assistant to document certain information in a patient's chart; requiring a collaborating physician to ensure that an advanced practitioner of nursing documents certain information in a patient's chart; revising the number of physician assistants and advanced practitioners of nursing that a physician may simultaneously supervise or collaborate with.
- R183-12    2)    Relating to physician assistants; amending the notification requirements for a physician assistant regarding any change in the supervision of the physician assistant by a supervising physician.

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The proposed amendments are necessary to establish Board of Medical Examiners policy and to clarify existing Board of Medical Examiners policy.
2. A copy of this notice and the regulations to be adopted will be on file at the Nevada State Library and Archives, 100 N. Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulations to be adopted will be available at the office of the Nevada State Board of Medical Examiners at 1105 Terminal Way, Ste. 301, Reno, Nevada 89502, and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulations are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at <http://www.leg.state.nv.us>. Copies of this notice and the proposed regulations will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.
3. The proposed amendments will not have a direct economic effect on the business of the practice of medicine or the public.

4. Enforcement of the proposed amendments will not result in an increased cost to the Nevada State Board of Medical Examiners.
5. To the Board's knowledge, the proposed amendments do not overlap or duplicate the regulations of other state or local governmental agencies or any federal regulations.
6. The proposed regulations do not establish new fees or increase existing fees.

Persons wishing to comment upon the proposed regulations of the Nevada State Board of Medical Examiners may appear at the scheduled public hearing or may address their comments, data, views, or arguments, in written form, to the Nevada State Board of Medical Examiners, 1105 Terminal Way, Ste. 301, Reno, NV 89502.

Written submissions must be received by the Nevada State Board of Medical Examiners on or before **February 12, 2013**. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Board of Medical Examiners may proceed immediately to act upon any written submissions.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
