The purpose of the hearing is to receive comments from all interested persons regarding general topics relating to the Driver Authorization Card, driver's licenses, identification cards, and commercial licenses. The topics of discussion are:

1. SB303, Section 5(3)(g); Additional Residency Documents that may be accepted by the DMV;
  - a. **DMV proposed additional documents that may be submitted as proof of residency** (2 documents required by SB303):
    - i. Tax records for the individual
    - ii. Bill or statement for a request of payment
    - iii. Record of property taxes assessed or paid in this state
    - iv. Deed or documentation of a mortgage

- v. Enrollment records or an identification card from an educational institution in this state
  - vi. Receipts from a motel, hotel, campground or recreational vehicle park showing 30 consecutive days of residency
  - vii. Voter registration card issued by the Nevada Secretary of State
  - viii. Documentation of receipt of public assistance from this state
  - ix. Military leave and earnings statement (LES) to evidence Nevada residency when deployed out of Nevada
  - x. Notarized statement from owner of property indicating the individual physically resides at the property
  - xi. Documentation applicant is enrolled in the Nevada Confidential Address Program (CAP)
  - xii. Department approved form for Nevada residency
2. SB303, Section 5(2); “No document which is written in a language other than English may be accepted by the Department pursuant to this subsection unless it is accompanied by a verified translation of the document in the English language.”
- a. **DMV proposed translation requirements:**
    - i. Documents accepted pursuant to subsection 5 of SB303 that are translated from another language to English must include:
      - (a) A typed or electronically printed translation only;
      - (b) The full and complete translation of the entire document;
      - (c) A typed or electronically printed statement conveying, “I, ~~insert translator’s full legal name~~, certify that the foregoing is a complete and accurate translation from ~~insert foreign language~~ to English to the best of my ability and belief. I further certify that I am fully competent to translate from English into ~~insert foreign language~~ and that I am competent in both languages.”; and
      - (d) A notarial officer signature subscribing witness pursuant to Chapter 240 of the Nevada Revised Statutes;
    - ii. Both the original language and translation are considered one document.
    - iii. Any name variation from any identity document must be accompanied by documentation as set forth in NAC 483.055.
3. Ensure that the various Driver Authorization Card requirements and consequences align with those for a Driver’s License Card currently adopted in Chapter 483 of the Nevada Administrative Code.
4. SB503: Creating language for specific processes to be established so the Department can successfully transition eligible driver’s license, identification cards, and commercial drivers to a card that expires in 8 years.
5. SB244: Creating clarifying language in regulations to allow commercial driver’s the ability to have a veteran’s designation on their license.

6. SB423: Creating language to request supporting documentation be provided when a person presents the Nevada Department of Correction Identification card only as proof of their name and date-of-birth.
7. Requesting a \$.25 cent increase to the card production fee adopted under NAC 483.900 to pay for vendor costs to produce the card.
