**NOTICE OF INTENT TO ACT UPON REGULATION
RE: R067-13**

Notice of Hearing for the Adoption, Amendment or Repeal of Regulations of
The Department of Business and Industry, Division of Insurance

The State of Nevada Department of Business and Industry, Division of Insurance (“Division”), (775) 687-0700, previously provided notice regarding a public hearing scheduled to take place on November 13, 2013, at 9:30 a.m., at the Division’s office located at 1818 East College Parkway, 1st floor hearing room, Carson City, Nevada 89706, with videoconferencing to the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104. The intended purpose of the hearing was to receive comments from all interested persons regarding the adoption, amendment or repeal of the regulation(s) that pertains to chapter 690B of the Nevada Administrative Code (“NAC”) concerning:

LCB File No. R067-13. Limited Automobile Policy Disclosure.

A regulation relating to casualty insurance; revising provisions relating to certain notices for policies of automobile insurance; and providing other matters properly relating thereto.

At the public workshop held in this matter on October 30, 2013, the Division proposed revisions to the regulation which were determined by the Hearing Officer to be substantive, requiring additional review by the Legislative Counsel Bureau (“LCB”). The Hearing Officer canceled the hearing on LCB File No. R067-13, set for November 13, 2013 at 9:30 a.m., in order to schedule a future hearing subsequent to LCB’s re-review.¹ The subsequent hearing will be properly noticed again pursuant to chapter 233B of NRS.

A copy of this cancellation notice will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice will be available at the offices of the Division, 1818 East College Parkway, Suite 103, Carson City, Nevada 89706, and 2501 East Sahara Avenue, Suite 302, Las Vegas, Nevada 89104, and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours.

¹ The hearing on proposed regulation LCB File No. R074-13, concerning Exchange Enrollment Facilitators, set to take place on November 13, 2013 at 9:30 a.m., is NOT CANCELED and will go forward as scheduled.
