Possible action may include offering Peter Krueger or another lobbyist a contract for professional services for the 2015 Legislative session.

The Commission will discuss ideas for public education and outreach for the NVOHVC in the state of Nevada. The discussion may include the NVOHVC performing its own efforts or soliciting other offers available. Possible action may include forming a committee to help with these efforts.

10. **ENFORCEMENT OF NVOHVC REGISTRATION STICKER PROGRAM (For Discussion and Possible Action)**

The Commission will discuss how to solicit appropriate advice from the statewide law enforcement community on how to effectively and intelligently enforce the NVOHVC registration sticker program. Possible action may include forming a committee to help with these efforts. Possible action may include receiving authorization to approach law

enforcement (local, county, state and federal) in order to request a comprehensive and effective plan and bring information back to the commission.
