NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Adoption of the Amendment to NAC 565.210

Regulation of the Nevada Department of Agriculture
Division of Animal Industry

The Nevada Department of Agriculture will hold a public hearing on, February 29th 2016 8:30 a.m.-9:30 a.m. 405 S. 21st Street, Sparks, Nevada, 89431. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of the amendment to NAC 565.210 Brand Inspection Districts.

The following information is provided pursuant to the requirements of NRS. 233B.0603:

1. The amendments to the adopted regulation are necessary to create clear and concise regions for Nevada Department of Agriculture and small business to regulate and operate efficiently.
2. Amendments to be adopted for this regulation replace the previous ten districts and create four concise boundaries to be regulated.
3. There are no additional costs associated with the amendments made to this regulation.
 - a. The long term effects of this amendment create clear boundaries for small business to operate and enable the Nevada Department of Agriculture to enforce brand inspection regulations more effectively.
4. There is no additional cost to the agency to enforce the proposed regulation.
5. The proposed regulation does not duplicate or overlap with any state, federal or local government regulation.
6. There are no federal regulations that apply.
7. The proposed regulation does not include any provisions more stringent than a federal regulation that regulates the same activity.
8. The proposed regulation does not increase or establish any new fees.

Persons wishing to comment upon the proposed action of the Nevada Department of Agriculture may appear at the scheduled public hearing or may address their comments, data, views, or arguments, in written form, to the Nevada Department of Agriculture located at 405 S. 21st Street, Sparks, Nevada, 89431. Written submission must be received by the Nevada Department of Agriculture on or before February, 29th 2016. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada Department of Agriculture may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be amended will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business

hours. Additional copies of the notice and the regulation to be amended will be available at the Nevada Department of Agriculture and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at <http://www.leg.state.nv.us>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of the regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principle reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
