 - a. Under existing law, the Director of the Department of Health and Human Services is required to establish a statewide health information exchange system and a governing entity for the system. SB48, enacted in the 78th Legislative Session, eliminated the requirement that the Director establish a statewide health information exchange system, and requires the Director to establish a regulation for health information exchanges. This proposed regulation prescribes the requirements for a statewide health information exchange.**
