

# PROPOSED REGULATION OF THE STATE BOARD OF HEALTH

### Voluntary Health Care Service Proposed Regulation Changes

Authority: NRS 629.400

**Section No. 1 *Definitions. (NRS 629.490) As used in Section No. 1 to Section No. 7, inclusive, unless the context otherwise requires, the words and terms defined in NRS 629.400 to NRS 629.490, inclusive, have the meanings ascribed to them in those sections.***

**Section No. 2 *“Division” defined. (NRS 629.420) “Division” means the Division of Public and Behavioral Health of the Department of Health and Human Services.***

**Section No. 3 *“Professional liability insurance” defined. (NRS 690B.240) “Professional liability insurance” means a policy of insurance covering the liability of a practitioner for a breach of his or her professional duty toward a patient.***

**Section No. 4 *“Principle individual” means the officer or official of the sponsoring organization responsible for operations of the sponsoring organization.***

**Section No. 5 *“Division Filing Officer” means an employee of the Division authorized to review all registration, reporting, and supporting documentation from the sponsoring organization pursuant to NRS 629.400 to NRS 629.490, inclusive.***

**Section No. 6 *Registration with the Division. Requirement; registration form.***

**1. *A sponsoring organization who wishes to provide voluntary health care service in the State of Nevada must first register with the Division using the Division prescribed registration form not less than 10 business days prior to the scheduled event. The registration must include, without limitation, all that is detailed in NRS 629.460, and:***

**(a.) *The physical location where voluntary health care service will take place;***

**(b.) *The inclusive date(s) and hour(s)s of operation of voluntary health care service to be provided; and***

**(c.) *A description of all types of health care services intended to be provided.***

**2. *The Division may require a sponsoring organization to provide any additional information that the Division determines is reasonably necessary.***

**3. *If additional providers of health care service are affiliated with the sponsoring organization for an event after the registration form has been submitted to the Division, the sponsoring***

*organization shall notify the Division electronically within 1 business day with the following information:*

- (a.) The full name and profession of the provider as it appears on the provider's license; and*
- (b.) The license number, expiration date, and state of license.*

*4. A copy of the signed and dated approval letter by the Division Filing Officer must be provided for inspection by the Division if requested on the date(s) of the corresponding event where voluntary health care service is being provided.*

**Section No. 7 Quarterly Report.**

*1. The sponsoring organization must file a report with the Division no later than 10 days after the end of each calendar quarter identifying each provider of health care who provided voluntary health care service during the calendar quarter in association with the sponsoring organization pursuant to NRS 629.460. If no voluntary health care service took place in association with the sponsoring organization during the previous calendar quarter, no report will need to be filed with the Division.*
