

# **HEARING CANCELLATION NOTICE**

## **NOTICE OF INTENT TO ACT UPON REGULATION LCB FILE NO. R031-17**

Notice of Cancellation of Hearing Date  
(with new date yet to be determined and noticed)  
for the Adoption, Amendment or Repeal of Regulations of the  
State of Nevada, Department of Business and Industry, Division of Insurance

The State of Nevada, Department of Business and Industry, Division of Insurance (“Division”), (775) 687-0700, previously provided notice regarding a public hearing scheduled to take place at 1:30 p.m. on November 9, 2017, at the Division’s offices in Carson City and Las Vegas. The intended purpose of the hearing was to receive comments from all interested persons regarding the adoption, amendment or repeal of regulations pertaining to chapter 686A of the Nevada Administrative Code (“NAC”), concerning:

**LCB File No. R031-17. Automobile Total Loss Settlements.** A regulation relating to insurance; revising provisions establishing minimum standards for claims settlement practices for the settlement of claims for automobile total loss; eliminating certain obsolete language; and providing other matters properly relating thereto.

Based upon comments received in writing and at the public workshop held in this matter on October 25, 2017, the Division has proposed revisions to the regulation which require additional review and drafting by the Legislative Counsel Bureau (“LCB”). At the workshop, the Hearing Officer continued the scheduled hearing in order to schedule a future hearing date subsequent to LCB’s production of a revised draft of the proposed regulation. The new hearing date will be set and properly noticed again pursuant to chapter 233B of NRS.
