This regulation is necessary because the passage of SB 225(2017) requires the Department of Education to amend the model policy required pursuant to NRS 388.135. The required amendments to the model policy must include 1) an allowance that an administrator or governing body of a private school may elect to comply with anti-bullying provisions of the regulation; 2) requirements and methods that public schools must use when addressing the rights and needs of persons of diverse gender identities or expressions; and 3) language clarifying that anti-bullying provisions of regulation apply to all public schools including charter schools.

Summary of public responses:

The following responses were consistent and repetitive at each of the three public hearings. This includes both the public comments provided at the public hearing as well as the written/email responses received.

Against:

- The regulation is wrong because it is determined on children's preferred identity, not the biological gender given by God. Moral values are not promoted, rather it is corrupting.
- The regulation is not about establishing a safe and respectful environment. Instead they are a thinly veiled attempt to indoctrinate students into an ideology that states biological sex and gender are unrelated.
- Calling a transgender student by their preferred pronoun will force schools to accept what many parents object to. The instructions in the bible should be followed. Gender is not fluid. It is ordained by God.
- Parents were not involved in the process, and they have the right to decide what and how to teach their children about sex education.
- The policies are a violation of the first amendment right of free speech and religion.
- Women and girls will be put in danger in changing room facilities, showers and bathrooms. The policy is a war on girls and is a assault waiting to happen.
- It is not possible to legislate the bully out of a child.
- It is hypocritical because it grants privilege's to eight percent of the student population.
- Scientific evidence does not support trans-gender theories.
- Parents fear what will happen in bathrooms and locker rooms; men will take advantage of this policy in the female bathroom and locker rooms.
- Children will be punished or suspended for using the wrong pronoun.
- Anti-bullying laws are already in place to protect all students and focus needs to be on subjects that will make students successful.
- Language is too broad, violates the rights of free speech, practice of faith, and rights fo association.
- The March 30, 2018 public hearing was scheduled on Good Friday and during spring break in CCSD.

In Support:

- The policy will help integrate all students to the educational system by providing equal access to public accommodations in schools without fear of harassment and bullying.
- Schools need to be a safe place for students to expand their knowledge without fear of being bullied, either physically or mentally.
- Too many children suffer silently as they are marginalized, bullied or demeaned because of their differences. Too many LGBTQ youth contemplate suicide because of adverse societal interaction and messaging.
- NRS 388.135 establishes a safe and respectful learning environment, and provides enumerated protections for LGBTQ students. SB225 passed during the 2017 Legislative session expands these protections and mandates that the Nevada Department of education pass this regulation to provide students with diverse gender identities and expression with equitable access to the protections provided in Nevada's anti-bullying statutes.
- It should be the role of the government to protect the minority.
- The constitution guarantees a separation of church and state which means that religious arguments have no place in government or in public schools in determining policy.
- Per the Nevada accommodations law students have already had access to the bathrooms and lockers rooms for years.
- Senate Bill 225 was signed into law by Governor Sandoval on June 13, 2017. It is now the law of Nevada.
- The three years Washoe County School District has had with their gender inclusive policy there have been no incidence of abusing the policy or causing harm to other students in restrooms or locker rooms.. There are laws that will hold accountable anyone who creates a disturbance in any public place.
- The regulations are not radical and reflect best practices implemented over many years in school districts throughout the United States.
- The anti-bullying law in CCSD states there should be respect for all students

Anti-LGBTQ special interest groups want you to think these students pose a threat to the safety and privacy of other students, but that is simply not true. LGBTQ students – especially those who are transgender or gender diverse – face violence and bullying at greater rates than their cisgender peers.

These are people. Not just people, but children. We can't sit around idle and let people bully them and push them deeper into the closet. They should be free to live as openly as possible. These children should be living these formative years of their life as freely and happily as possible. They aren't monsters. They aren't evil. They're our sons and our daughters. And they are in danger. I implore you to take action and protect them. They need you now more than ever.

Principals and school leaders need the guidance and support of this policy, and sex and gender diverse students need safe and respectful learning environments.

Thank you for doing the right thing.
