## Legislative Review of Adopted Regulations as Required by NRS 233B.066 Nevada Regulation Amendment R149-17

The following statement is submitted for adopted amendments to Nevada Regulation Amendment R149-17

## 1. A clear and concise explanation of the need for the adopted regulation.

NAC 449.960 currently requires that certain institution, including hospitals, file with the Department of Health and Human Services financial statements or reports in a form and at intervals specified by the Director of the Department. The Director requires each hospital to submit for each calendar quarter completed financial and utilization report. The adopted amendments will clarify that a hospital is not required to include in such a report financial and utilization data concerning certain patients admitted to the hospital pursuant to the order of the court.

## A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

Copies of the proposed regulations, notices of workshop, Notices of Intent to Act Upon the Regulation were emailed to all persons on the agency's mailing list for administrative regulations and made available at the DHCFP Carson City central office, 1100 E. Williams Street, Suite 101, Carson City, NV 89701; Las Vegas DHCFP, 1210 E.. Valley View Blvd. Suite 104, Las Vegas, NV 89416 and the DHCFP Web site <a href="https://www.dhcfp.nv.us">www.dhcfp.nv.us</a>. It was posted to all county libraries in Nevada and the Nevada State Library. The Notice of Public Hearing and the regulation to be amended were on file at the State Library and Public Library in addition the text was of the proposed regulation were available in the State of Nevada Register of Administrative Regulations which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653 and on the Internet at <a href="http://www.leg.state.nv.us">http://www.leg.state.nv.us</a>, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public

On November 11, 2017 a Public Workshop was conducted via teleconference, in both Carson City and Las Vegas, at the Division of Health Care Financial and Policy (DHCFP) conference room.

There was no public comment at the Workshop. The Public Workshop Minutes contain a summary of the discussion held regarding the proposed regulation and are attached.

On May 24, 2018 a Public Hearing was held, via teleconference, in Carson City at the Nevada State Legislative Building and in Las Vegas at the Grant Sawyer Office Building. One person other than DHCFP staff attended the Public Hearing, no public comment was made.

Comments were solicited from affected businesses in the same manner as they were solicited from the public.

If the regulations was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

There were no comments made to propose changing the proposed regulation, the regulation was adopted without change.

The adopted regulation will beneficially effect businesses by exempting hospitals from being required to file forensic financial and utilization data quarterly. There is no anticipated cost as a result of the implementation of these changes; therefore, no adverse effect on businesses. The adopted regulation has no anticipated effect, adverse nor beneficial, on the public.

(b) Both immediate and long-term effects.

The adopted regulation will effect businesses, both immediate and long-term, by exempting hospitals from being required to file forensic financial and utilization data quarterly. The adopted regulation has no anticipated effect on the public, short term or long term.

There is no cost anticipated for the implementation of these changes.

The proposed regulation will exempt hospitals from being required to file forensic financial and utilization data quarterly. There is no anticipated cost or burden to small businesses as a result of the exemption of forensic data.
