AUTHORITY: §1, NRS 501.105, 501.181 and 503.452, as amended by section 5 of Senate Bill No. 364, chapter 333, Statutes of Nevada 2017, at page 1998.

A REGULATION relating to trapping; revising provisions governing the registration of a trap, snare or similar device; setting forth the requirements for affixing a registration number to the trap, snare or similar device; and providing other matters properly relating thereto.

Section 1. NAC 503.150 is hereby amended to read as follows:

- 503.150 1. A person ~~[may]~~ *who is required to register a trap, snare or similar device pursuant to NRS 503.452, as amended by section 5 of Senate Bill No. 364, chapter 333, Statutes of Nevada 2017, at page 1998, shall apply to the Department for a trap registration number. ~~[obtain an application form for registering a trap from any office of the Department. The forms]~~ Unless the information already exists in Department records, applications must ~~[be completed in accordance with the instructions thereon]~~ include the following: applicant's legal name, date of birth, social security number, and mailing address.*
2. The Department shall issue *a* registration number ~~[s beginning with NV 0001. The]~~ *to the applicant for traps, snares or similar devices used pursuant to this section. Each*

registration number ~~[must]~~ :

(a) Is transferable; and

(b) Must be clearly and legibly stamped ~~[on]~~ :

(1) On the trap , snare or similar device; or ~~[on]~~

(2) On a metal tag that is attached to the trap ~~[,]~~, snare or similar device or secured to its attached chain, cable or wire.

3. Each trap, snare or similar device must display only the registration number of the person who is the owner of the trap, snare or similar device. Any other registration number must be stricken, obliterated or removed from the trap, snare or similar device.

4. ~~[The person shall enter the appropriate registration number on his or her trapping license.]~~A person who is required to register a trap, snare or similar device pursuant to NRS 503.452, as amended by section 5 of Senate Bill No. 364, chapter 333, Statutes of Nevada 2017, at page 1998, shall pay a fee of \$5 for each trap, snare, or similar device registered with the Department.

a) The Department shall issue a metallic seal to the person registering a trap, snare or similar device for each trap, snare, or similar device in use.

b) The metallic seal shall be attached to each trap, snare, or similar device in use, or attached to the anchoring chain, cable, or wire of each trap, snare, or similar device in use.
