

INFORMATIONAL STATEMENT FOR  
REGULATION PROPOSED BY THE NEVADA STATE BOARD OF PODIATRY  
(LCB No. R067-18)

The following statement is submitted for the proposed amendment and additions to NAC chapter 635.

1. A clear and concise explanation of the need for the adopted regulation.

*The need and purpose of the proposed regulation is to add language regarding violations of drug laws related to the Nevada Board of Pharmacy as unprofessional conduct as disciplinary language as required in AB 474 of the 2017 Legislature.*

2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

*On March 12, 2018, the Board held a workshop at its regular meeting regarding the draft language that ultimately became R067-18. No member of the public attending the meeting offered comment during the workshop and no written comments were received regarding the language that ultimately became R067-18.*

*On July 16, 2018, the Board held a regulation hearing regarding R067-18 at its office in Reno, Nevada and telephonically. Copies of the Notice of Hearing and the proposed text of R067-18 were e-mailed to all of the Board's licensees for whom the Board had e-mail addresses and mailed to all people who have sought such public documents pursuant to the Nevada Open Meeting Law. The Board sent the Notice of Hearing and proposed text of R067-18 to a total of 146 people. At the hearing, no member of the public attending the meeting commented and no written comments regarding R067-18 were received. The regulation was passed unanimously without amendment.*

*No changes were made, and the language of R067-18 was adopted unanimously by the Board without amendment.*
