

## NOTICE OF INTENT TO ACT UPON REGULATION R094-18

Notice of Hearing for the Adoption of Regulations of the Board of Examiners for Marriage and Family Therapists and Clinical Professional Counselors

The Board of Examiners for Marriage and Family Therapists and Clinical Professional Counselors will hold a public hearing at 9 a.m., on the 24th of August of 2018, videoconferenced between

The purpose of the hearing is to receive comments from all interested persons regarding the Adoption of regulations that pertain to chapter 641A of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of [NRS 233B.0603](#):

*1. The need for and the purpose of the proposed regulation or amendment.*

The need and purpose of the proposed regulations is to protect the health, safety, and welfare of the public by removing barriers to behavioral health care by streamlining Board processes, enhancing academic requirements, facilitating and expediting licensure, and improve regulatory clarity.

*2. If the proposed regulation is a temporary regulation, the terms or the substance of the proposed regulation to be adopted, amended or repealed, or a description of the subjects and issues involved.*

*4. The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately and in each case must include:*

(a) Both adverse and beneficial effects;

No adverse effects upon small business are anticipated and none have been brought to the Board's attention. Beneficial effects include an increased ability to hire licensed clinicians at a more frequent rate than is currently possible, thereby augmenting workforce and expanding care to citizens.

(b) Both immediate and long-term effects.

The immediate and long-term effects are similar in that an anticipated burgeoning behavioral healthcare workforce will bolster Nevada's overall economy with clinical jobs and improved mental wellness of the citizenry.

5. *The methods used by the agency in determining the impact on a small business.*

In addition to several Board members' own anecdotal experience in owning and operating several small businesses, in the three public workshops spread across seven months, zero public feedback anticipated a negative impact on small business, with several comments stating a potential positive impact, including the ease of hiring licensees and, subsequently, faster augmentation of services to clients.

6. *The estimated cost to the agency for enforcement of the proposed regulation.*

The Board's costs are anticipated to drop following adoption of these changes by streamlining processes and improving workflow.

If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Board of Examiners for Marriage and Family Therapists and Clinical Professional Counselors may proceed immediately to act upon any written submissions.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
