

**LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY  
NRS 233B.066  
PERMANENT REGULATIONS**

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 643.

**1. A clear and concise explanation of the need for the adopted regulations.**

These regulation changes are necessary to provide updated language to the NAC codes of Chapter 643.

**2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.**
