## LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233b.066 LCB FILE R003-19

*Revised: 2/23/21*

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 656.

1. This regulation is necessary to update the regulations and keep consistent with statutory changes and provide clarification to court reporters and designated representatives of court reporting firms.
2. Copies of the proposed regulations, notice of workshop and notice of intent to act upon the regulation were sent by email to persons who were known to have an interest in the subject of court reporting as well as any persons who had specifically requested such notice. 4. A list of names and contact information for each person identified above in #3, is attached as Exhibit A.
5. Notices of the workshop and adoption hearing to solicit comments were sent out to each active court reporter and designated firm representative registered with the State of Nevada Certified Court Reporters Board. The notice instructed interested persons to contact the Executive Secretary to submit their comments or request a copy of the materials. No verbal or written comments were received at the workshop and adoption hearing.
6. The permanent regulations outlined in R003-19 was adopted by the Board on January 12, 2021 in its entirety as prepared by the Legislative Counsel Bureau. The Board determined the proposed regulations provided clarification relating to fee structures, deadlines for renewal fees and continuing education credits.
7. The Board does not anticipate any adverse economic effect to businesses or to the public. The beneficial and long term effects of the proposed regulation will provide clarification relating to fee structures, deadlines for renewal fees and continuing education credits to businesses and to the public. The immediate and long term effects will keep NAC Chapter 656 consistent with NRS Chapter 656 and provide clarification for court reporters and court reporting firms in the state of Nevada.
8. There is no additional cost to the Board to enforce these regulations.
9. There are no other state or governmental agency regulations that the regulation duplicates.
10. There are no federal regulations that apply.
11. Section 1(1)(c) introduces a reinstatement fee of \$125.00 to be applied to certificate holders who wish to reinstate their certificate due to suspension resulting from a disciplinary matter or their failure to pay their renewal fee by the due date. Based on the breakdown below, we estimate approximately 3 reinstatement requests per year. A total of \$375.00 per fiscal year. Any monies collected will be used towards administrative costs to process the request and the remaining monies will be used towards general expenditures to operate the office.

FY20 – 6 Certificate Reinstatements  
FY19 – 2 Certificate Reinstatements  
FY18 – 1 Certificate Reinstatement

Section 1, sub-section 3 introduces a new fee that will be charged and collected to expedite any request for service, in an amount not to exceed the actual cost to the Board for expediting the service. The cost has not been determined at this time.
