LEGISLATIVE REVIEW OF ADOPTED REGULATIONS--NRS 233B.066 Informational Statement LCB File No. R015-19

1. A clear and concise explanation of the need for the adopted regulation.

The amendment to NAC 284.405 in Section 1 of the regulation is necessary to ensure that an employee who becomes unable to perform the essential functions of his or her position and commences the reassignment process, is aware of his or her reassignment rights and will not unknowingly forfeit these rights.

The amendment to NAC 284.586 in Section 3 of the regulation encourages staff to take advantage of early voting and is necessary in order to allow more flexibility regarding staffing levels during the period of early voting and on election day by stretching the time off to vote of staff over a longer period of time. Without this amendment, supervisor and managers may experience untenably low staffing levels on election day.

Section 1 of the regulation makes conforming changes based on the amendment to NAC 284.405 and the renumbering of subsections.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

On November 1, 2019 copies of the proposed regulation amendments were sent by email to persons who were known to have an interest in the subject of proposed personnel regulation changes as well as any person who had specifically requested such notice via Listserv.
