During the multi-year process of establishing regulatory provisions for the education and training of physical therapists practicing dry needling, the Board solicited and considered input in determining educational and training requirements, economic impacts, and benefits to the public. The Board conducted a survey of licensed physical therapists to help identify entry-level knowledge, skills, and abilities that are important for competency in dry needling. Data gathered from the board survey was considered along with results of a practitioner survey conducted by the Human Resources Research Organization (HUMRRO) in a report prepared for the Federation of State Boards of Physical Therapy. Further, the Board created an advisory committee to further identify regulations to ensure dry needling is performed competently, safely and within a physical therapist's scope of practice. The advisory committee was comprised of representatives of the physical therapy community, the oriental medicine community, and the nursing community.

On July 6, 2018, a public workshop was held in conjunction with a board meeting to receive comments and input from interested persons regarding proposed regulation regarding dry needling. After passage of Senate Bill (SB) 186 of the 2019 Nevada Legislative Session, a joint workshop was held with the Nevada State Board of Athletic Trainers on July 26, 2019, to provide comments on dry needling by physical therapists and athletic trainers in NAC 640 and NAC 640B. The minutes of the workshops held on July 6, 2018, and July 26, 2019, attached hereto, contain a summary of the discussion held regarding the proposed amendments. Thereafter, on November 15, 2019, the Executive Director issued a Notice of Intent to Act Upon a Regulation, receiving and considering public comments and input for incorporation in the proposed amendments.

Copies of meeting agendas, meeting minutes, proposed regulations, workshop notices and notices of intent to act were posted and provided to persons who were known to have an interest in the subject. These documents were also made available pursuant to the provisions of chapters 233B and 241 of Nevada Revised Statutes.

Comments were solicited from affected businesses in the same manner as they were solicited from the public. The summary may be obtained as instructed in the response to question #2.

6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

The permanent regulation was adopted without change on November 15, 2019 by the Nevada Physical Therapy Board and the State Board of Athletic Trainers after review, discussion and consideration of comments and input received from interested persons on proposed dry needling.

The Nevada Physical Therapy Board and State Board Athletic Trainers received comments relating to: qualifications and training requirements, handling procedures and needle retention. After discussion, the Boards determined that the comments did not merit any change to the proposed regulation due to the following:

The proposed regulation adequately addresses each comment received. Dry Needling was added to the Physical Therapy Practice Act in the 2019 Legislative Session 2019 through Senate Bill 186. Existing law requires the Nevada Physical Therapy Board to:

- 1) Prescribe by regulation the qualifications required for a physical therapist to perform dry needling. Those qualifications must include the completion of at least 150 hours of certain didactic education and training in dry needling.
- 2) Prescribe by regulation procedures concerning the handling of needles used to perform dry needling
- 3) Prescribe by regulation procedures to ensure that a physical therapist does not engage in needle retention.

The proposed regulation brings compliance with the above-referenced provisions by establishing the qualifications a physical therapist must obtain before he or she is authorized to perform dry needling. Additionally, public comments are resolved in the following sections:

a.	 Qualifications a physical therapist or athletic trainer must obtain before he or she is authorized to perform dry needling. ☐ Section 2, Item 2 addresses the didactic education and training requirements of physical therapist performing dry needling.
b.	Procedures concerning the handling of needles used to perform dry needling. Section 3, Item 2(b) addresses the handling of needles, requiring a physical therapist who performs dry needling to dispose of those needles after completing a portion of a procedure performed on a specific area of the body or, if the entire procedure is performed on one area of the body, after completing the procedure.
c.	Procedures to ensure that a physical therapist or athletic trainer does not engage in needle retention. □ Section 3, Item 2 (a) addresses needle retention, requiring a physical therapist who performs dry needling to use only single-use, single-insertion needles.

- 7. The estimated economic effect of the adopted regulation on the businesses which it is to regulate and on the public. These must be stated separately, and each must include:
 - a. Both adverse and beneficial effect on businesses:

The intent of the proposed regulations under R054-19 should have no adverse or beneficial economic effect on businesses that will be subject to the regulation. To date, the Board has not received any comments in writing or at any of its meetings that indicate that the regulations will have any economic effect, either adverse or beneficial.

b. Both adverse and beneficial effect on the public:

No adverse effects on the public are anticipated from the proposed regulation. The Nevada Physical Therapy Board anticipates that the regulation will provide beneficial effects for the public through the establishment of professional standards of training and education qualifications for the delivery of dry needling skilled intervention, to help maintain the highest standards for public safety.

c. Both immediate and long-term effects on the public:

This proposed regulation does not have an anticipated immediate or long-term economic effect on the public. Public safety benefits to the public will be immediate and continue for the longer term.

8. The estimated cost to the agency for enforcement of the adopted regulation.

There is no additional cost to the agency for enforcement of this regulation.

9. A description of any regulations of other state or government agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the regulation overlaps or duplicates a federal regulation, the name of the regulating federal agency.

There are no other state or federal regulations that overlap or duplicate the regulation. SB186 required the State Board of Athletic Trainers to also adopt regulations establishing the qualifications an athletic trainer must obtain before he or she is authorized to perform dry needling. The Nevada Physical Therapy Board and the State Board of Athletic Trainers collaborated on proposed regulations to revise Chapter 640 and Chapter 640B of the Nevada Administrative Code, satisfying both Board's requirements under SB186.

There are no federal regulations that apply.

Northern Nevada Public Comment: Executive Secretary Roda received two written public comments and read them into the record.

 From: Steve McCauley, Legislative Chairman for the Nevada Athletic Trainers Association.

Dear members of the Nevada State Board of Athletic Trainers, my name is Steve McCauley and I am the Legislative Chairman for the Nevada Athletic Trainers Association. It is a pleasure to submit this testimony for this public hearing on the proposed regulation regarding dry needling. I will introduce suggestions in the subsequent paragraphs regarding the proposed changes to NRS 640B, according to SB186 of the 2019 Legislative Session.

- A. Qualifications: SB186 states that the qualifications must include without limitation successful completion of not less than 150 hours of didactic education and training in dry needling approved by the Board. The sum of current commercial education and training available does not meet the 150 hours of training and education required by SB186. I propose that athletic traininers who currently provide dry needling prior to July 1, 2019, be granted approval to continue to offer dry needling if they demonstrate 150 hours of service in the provision of dry needling, and are endorsed by a Nevada State licensed physician. In addition these individuals would be eligible to receive authority from the State Board of Athletic Trainers to provide didactic education to newly certified and educated athletic trainers of a board approved course in dry needling for the purposes of satisfying the 150 hours of didactic training and education required.
- B. The policy and procedures governing the handling, disposal and retention of dry needles must be provided to the State Board of Athletic Trainers as a requirement before that athletic trainer is granted a dry needling privilege. This policy and procedure must be endorsed by a Nevada state licensed physician.
- C. One final note on legislative intent related to both Chapter 640 and 640B. In Chapter 640B, an athletic trainers scope of practice requires direction from a licensed physician. Chapter 640 does not include that requirement. It is therefore important to consider the physician's approval when developing guidelines granting an athletic trainer privileges, which as stated previously is not a requirement in Chapter 640 governing physical therapists.

At Cirque Du Solei, our therapists and artists have come to rely on dry needling as a valuable adjunct to our injury management techniques, improving the time to resolution for an injury and minimizing the impact of injury and disability for the artists and the show.

Concerns: We agree in the proposal that only athletic traininers and physical therapists who are properly trained in this treatment technique, should be administering to its patients. However, the educational requirements currently proposed for dry needling are unclear and do not match the standards set in neighboring state regulations. We would like further clarification as to what is considered "150 hours of didactic education and training in dry needling approved by the board." Most reputable educational institutions offer courses in dry needling that are 25 – 30 hours with lecture and lab components taught at a low instructor to student ratio. We are concerned that the 150 hours of didactic eduction proposed is high, particularly as our therapists have accumulated 100s of treatment hours over their years of practice, in addition to maintaining compliance with rigorous education standards by their state, national and international regulatory boards.

Summarization of Dry Needling: Dry needling is defined as the insertion of solid filform needles into muscles, ligaments, tendons, subcutaneous fascia, scar tissue and bones for the purpose of reducing pain, muscle tension and facilitating accelerated return to activity. Research has shown that this treatment stimulates a physiological response resulting in fasodialation, pain modulation in the local, segmental and systemic levels. These studies have established that dry needling treatment delivered by

athletic trainers and physical therapists is effective in the management of pain and neuromusculoskeletal dysfunction, and that targeting trigger points and non trigger point tissue is effective in decreasing pain and disability. Evidence Supporting Dry Needling: Referenced seven (7) articles.

Nevada Physical Therapy Board Chairman Smith confirmed with Executive Director Harvey that the Board had not received any written comments as of 12:00 pm on 7/26/2019.

Senior Deputy Attorney General Bradley advised both Boards to fully consider the public comments and decide whether or not those comments merit any change to the proposed regulations. Members also discussed the public comments provided by Mr. Satchler regarding needle retention.

Chair Smith discussed two different forms that the Nevada Physical Therapy Board will be working on. These include an educational form that licensees will have to complete to show how they meet the training hour requirements, and an attestation form for licensees who may not have their certificates of education. Licensees are only required to keep these records for four years, although they may be able to contact their provider to obtain copies. This form would also apply to licensees currently practicing dry needling who may have received training eight or nine years ago and do not have copies of their certificates. These licensees will be able to attest under penalty of perjury that the training information they are providing is true and accurate. Senior Deputy Attorney General Bradley informed board members that if a licensee provides false information and we find out about it, they will be investigated and disciplined

Dear Board members,

The following is a response from ATI Physical Therapy to the request for information as it relates to dry needling and proposed changes to revise Chapter 640 and Chapter 640B of the Nevada Administrative Code. In the published <u>Notice</u> of <u>Intent to Act Upon a Regulation (October 10, 2019)</u>, the following are discussed as proposals to the regulations:

- Qualifications a physical therapist or athletic trainer must obtain before he or she is authorized to perform dry needling.
- 2) Procedures concerning the handling of needles used to perform dry needling.
- Procedures to ensure that a physical therapist or athletic trainer does not engage in needle retention.

The following comments are provided to assist in the commentary related to this topic and context to the practice of dry needling.

 Physical therapists and athletic trainers are highly trained individuals that complete a number of competencies during their education to become licensed healthcare providers. The Federation of State Boards of Physical Therapy (FSBPT) conducted an Analysis of Competencies for Dry Needling by Physical Therapists in July 2015 that included the following comment;

"86% of the knowledge requirements needed to be competent in dry needling is acquired during the course of PT clinical education, including knowledge related to evaluation, assessment, diagnosis and plan of care development, documentation, safety, and professional responsibilities."

As such, we would support the requirement to obtain additional knowledge related to the practical application of dry needling. Other states have adopted specific hour requirements for licensed physical therapists to perform this technique. For example, Maryland has defined the requirements as follows:

In order to perform dry needling, a physical therapist shall have at least 80 total hours of instruction, which includes:

- A total of at least 40 hours of instruction in the following dry needling-specific course content areas:
- (a) Theory and application of dry needling;
- (b) Dry needling technique, including spine and extremities;
- (c) Dry needling indications and contraindications;
- (d) Infection control, the Occupational Safety and Health Administration's

Bloodborne Pathogen Protocol, and safe handling of needles;

- (e) Emergency preparedness and response procedures related to complications associated with dry needling; and
- (f) Appropriate documentation of dry needling; and
- (2) At least 40 hours of practical, hands-on instruction in the application and technique of dry needling, under the supervision of a licensed health care practitioner competent in dry needling procedures who has:
- (a) Completed the requisite course work under §A(1) of this regulation; and
- (b) Practiced dry needling for at least 5 years.
- B. The instruction required under §A(1) of this regulation shall be provided by a continuing education course sponsored by the:
- (1) American Physical Therapy Association;
- (2) The APTA of Maryland; or
- (3) The Federation of State Boards of Physical Therapy.

This is one example of how the practical application can be addressed through a curriculum that also includes supervision by another provider in order to assess the physical therapist's capacity to demonstrate the technique in a skilled fashion. We believe this is one way and understand that other states have modeled similar methodologies that may include supervision of a specified number of procedures, a different amount of hours or a limitation on who may obtain the knowledge (must have practiced a certain length of time prior to completion of additional coursework/requirements). As it relates to physical therapists, supporting a competency that addresses these items is critical for those practicing dry needling.

To address dry needling by athletic trainers, while there may be similar initial training related to anatomy/physiology, kinesiology and assessment of musculoskeletal conditions, we are unaware of any current states that have included dry needling in the scope of practice for licensed provider. The National Athletic Trainers' Association has published the following:

"Currently, there is no profession-wide standard that defines athletic trainer competence in dry needling. Prior to performing dry needling, athletic trainers must ensure their state practice act does not prohibit them from performing dry needling as part of the athletic training plan of care. Additionally, athletic trainers must satisfy any requisite educational and training necessary to provide dry needling. Athletic trainers may have to produce evidence of appropriate training and demonstrate knowledge and competency in dry needling."

To support the process of athletic trainers utilizing dry needling, it is our stance that additional parameters above those identified in our previous commentary would be necessary. This would need to include additional curriculum related to both the principles of the technique as well as the practical application. The competencies as set forth by FSBPT could be utilized as a reference and basis to help develop this material.

- 2) Procedures related to the handling of needles is critical to the safety of both the practitioner as well as the patient. We believe that those individuals who have been granted the capacity to conduct dry needling would need to be compliant with the Needlestick Safety and Prevention Act. The Occupational Safety and Health Administration is responsible for oversight of these provisions and has provided the necessary guidance as it relates to the handling of needles. It is our opinion that these standards would need to be in place for all licensed providers that are able to handle needles.
- 3) As stated above, compliance with the Needlestick Safety and Prevention Act would need to be the standard for prevention against licensed clinicians who may consider retaining needles. An entity providing these services should ensure that staff are knowledgeable in bloodborne pathogens, infection control and safe handling. Clinic locations should have the appropriate equipment to capture and remove needles so that this may be occur after each usage with individual patients. Lastly, parameters should be in place to discipline individuals, who upon investigation, have been determined to be out of compliance.

Thank you for the opportunity to discuss our thoughts and recommendations as it relates to dry needling and the revision of Chapter 640 and Chapter 640B of the Nevada Administrative Code. The safety of patients is critical to the success of licensed providers such as physical therapists and athletic trainers. By clearly defining the scope of practice for these individuals, it helps to promote a compliant environment where providers can address the needs of those seeking care from them.

Nevada PT and Athletic Training Board Workshop November 15, 2019

Ladies and Gentlemen of the respective Boards, Good Afternoon!

I would like to comment on the proposed regulations regarding Dry Needling as described in Senate Bill 186.

Please allow me to introduce myself. My name is Kirk Sachtler. I have been a practicing Physical Therapist in Nevada for over 30 years and have been practicing Dry Needling since 2012, when our State Board authorized its use. Prior to that, I studied acupuncture for 15 years. I have a Doctorate in Physical Therapy and am a Board Certified Orthopedic Clinical Specialist, a Board Certified Sports Clinical Specialist, and Certified in Manual Therapy, Strength & Conditioning, and Dry Needling.

I would like to address the 3 aspects of today's workshop:

- 1) Training Qualifications
- Handling Procedures
- Needle Retention definition
- I am in agreement with the 25 hours of in-person graduate level education.
- 2) To the best of my knowledge, training in needle handling procedures and sterile technique is provided in all Dry Needling curricula, and I am in agreement with this requirement, as well as, the requirement to use needles for single use, single insertion only. The scientific evidence regarding the benefit of this is significant.
- 3) Regarding Needle Retention, however, I am quite perplexed. If by "Needle Retention" one means the duration of time a needle is allowed to remain in a patient, this is a concept currently being researched around the world, and one in which there is not yet agreement. Not even among acupuncturists. There are NO Dry Needling programs in the U.S. currently teaching a procedure in which a needle is placed in a patient and then immediately removed. If this becomes the definition, the Nevada PT Board would find itself in conflict with all of the Dry Needling Programs it is simultaneously certifying. I cannot support this definition, which is not backed by any evidence, nor used by any practitioners worldwide. I can only hope that the Board will develop a more flexible and "Therapeutic" definition for the benefit of the citizens of Nevada.
