### INFORMATIONAL STATEMENT

The informational statement required by NRS 233B.066 numerically conforms to the subsections of the statute as follows:

1. EXPLANATION OF THE NEED FOR THE ADOPTED REGULATION

The proposed amendment will license the use of a mechanical device or an automated drug dispensing system to furnish a prescription drug to a patient at certain locations off the premises of the pharmacy; establishes certain fees relating to the use of a mechanical device or an automated drug dispensing system; and revise regulatory requirements for mechanical devices. The regulation is necessary to ensure the delivery of safe and reliable pharmaceutical care and will benefit public health, safety, and welfare.

2. A DESCRIPTION OF HOW PUBLIC COMMENT WAS SOLICITED, A SUMMARY OF PUBLIC RESPONSE, AND AN EXPLANATION HOW OTHER INTERESTED PERSONS MAY OBTAIN A COPY OF THE SUMMARY.

The Board solicited comment on the proposed amendment by (1) posting notice, with links to the full text of the proposed amendment, to the LCB Administrative Regulation Notices webpage, (2) posting a copy of the full text of the proposed changes to the Board's website as part of the Board Hearing materials, (3) posting notice to the Nevada Public Notice website, operated by the Department of Administration, with a link back to a full text of the proposed amendment on the Board's website, and (4) posting notices and agendas in numerous public locations per NRS Chapter 233B.

The Board also solicited comment from Nevada dispensing practitioners, and from representatives of relevant industry associations that Board Staff deemed likely to have an interest in the proposed amendment. The Board further provided time for public comment at the workshop(s) concerning the proposed amendment.

5. IF THE REGULATION WAS ADOPTED WITHOUT CHANGING ANY PART OF THE PROPOSED REGULATION, A SUMMARY OF THE REASONS FOR ADOPTING THE REGULATION WITHOUT CHANGE.

The Board adopted LCB File R013-21 with conforming amendments to pages, 5, 7, 8; and conforming amendments to NAC 639.720.

The amendments to pages, 5, 7, 8 and NAC 639.720 of the LCB draft of proposed regulation R013-21 are attached.

6. THE ESTIMATED ECONOMIC EFFECT OF THE REGULATION ON THE BUSINESS WHICH IT IS TO REGULATE AND ON THE PUBLIC. THESE MUST BE STATED SEPARATELY, AND IN EACH CASE MUST INCLUDE:
  - A) BOTH ADVERSE AND BENEFICIAL EFFECTS.

There should be no adverse economic impact from this regulation amendment on the public. The amendment will have an economic impact on those pharmacies that wish to apply for licensure for a device. The amendment will have a beneficial economic effect on regulated entities and the public by improving the delivery of safe and reliable pharmaceutical care.

**B) BOTH IMMEDIATE AND LONG-TERM EFFECTS.**

The Board anticipates that there will be no immediate or long-term economic effect on the public, or that any such effects will be negligible. The amendment will have both an immediate and long-term beneficial economic effect on regulated entities and the public by improving the delivery of safe and reliable pharmaceutical care.

**7. THE ESTIMATED COST TO THE AGENCY FOR ENFORCEMENT OF THE PROPOSED REGULATION.**

The cost to the Board for enforcement of the proposed regulation cannot be determined at this time since it will be dependent upon the number of applicants for registration/licensure.

**8. A DESCRIPTION OF ANY REGULATIONS OF OTHER STATE OR GOVERNMENT AGENCIES WHICH THE PROPOSED REGULATION OVERLAPS OR DUPLICATES AND A STATEMENT EXPLAINING WHY THE DUPLICATION OR OVERLAPPING IS NECESSARY. The Board of Pharmacy is not aware of any similar regulations of other state or government agencies that the proposed regulation overlaps or duplicates.

**9. IF THE REGULATION INCLUDES PROVISIONS WHICH ARE MORE STRINGENT THAN A FEDERAL REGULATION WHICH REGULATES THE SAME ACTIVITY, A SUMMARY OF SUCH PROVISIONS.**

The regulation does not contain provisions which are more stringent than a federal regulation which regulates the same activity.

**10. IF THE REGULATION PROVIDES A NEW FEE OR INCREASES AN EXISTING FEE, THE TOTAL ANNUAL AMOUNT THE AGENCY EXPECTS TO COLLECT AND THE MANNER IN WHICH THE MONEY WILL BE USED.**

The regulation adds fees for the licensing of an automated drug dispensing system and the certification of certain mechanical devices. The revenue generated from the fees will partially offset the costs of regulatory enforcement by the Board of Pharmacy.
