Legislative Review of Adopted Regulations as Required by NRS 233B.066 LCB File R020-21

The following statement is submitted for adopted amendments to the Nevada Administrative Code (NAC) Chapter 644A.

1. Clear and concise explanation of the need for the adopted regulation.

The proposed regulation would allow for students to continue earning hours towards their cosmetology licenses even when schools of cosmetology are closed due to a Governor declared state of emergency. Giving students the ability to earn remote practical hours is meant to encourage students to complete their cosmetology programs and seeks to avoid delays in graduation due to school closures.

2. A description of how public comment was solicited, a summary of the public response, and an explanation of how other interested persons may obtain a copy of the summary.

Copies of the proposed regulations, notices of workshop and notices of intent to act upon regulation were sent by U.S. mail and emailed to persons who were known to have an interest in the subject of remote practical learning as well as any persons who had specifically requested such notice and all licensed schools of cosmetology. These documents were also made available at the website of the Nevada State Board of Cosmetology, www.nvcosmo.com, mailed to all county libraries in Nevada and posted at the following locations.

On May 10, 2021, a workshop was held to solicit comments from the general public related to the proposed regulation change to NAC 644A.618. At the time of the meeting, no public comments or written comments were submitted to the Board related to the proposed regulation change and as such, the Board voted to move forward with the regulation making process without any changes made to the draft regulation.

On January 31, 2021 Nevada State Board of Cosmetology issued a Notice of Intent to Act Upon a Regulation and on March 7, 2022 a public hearing was held in accordance with open meeting law. At the time of the hearing, none of the meeting participants, including Board members, had any comments on the unchanged, proposed regulation and as such, the Board voted to adopt the regulation as it appears in R020-021.

Both the May 10, 2021 workshop and the March 7, 2022 adoption hearing were held via remote technology system pursuant to AB 253 and NRS 241.023. Both meetings were held via ZOOM technology. The meeting minutes from both meetings are attached hereto as Exhibit A.

None of the attendees at either meeting (March 10, 2021 or March 7, 2022) offered any comments related to the proposed regulation. All of the comments made during the meeting were made during one of the public comment periods on a matter unrelated to the proposed regulation.

5. A description of how comment was solicited from affected businesses, a summary of their response, and an explanation of how other interested persons may obtain a copy of the summary.

To determine whether this proposed regulation change was likely to have an impact on small businesses, the Board of Cosmetology requested input from school owners and operators. A Typeform survey was sent to each of Nevada's licensed cosmetology schools asking for input as to the projected adverse and beneficial impacts of the proposed regulation change. A summary of the responses is attached as Exhibit B.

Executive Director Landry explained once the package is sent to the LCB, it will come back to the Board and we can discuss the changes the LCB made. Director Landry further explained that the Board's submission of the package, including the survey to the LCB, is so that the LCB may see the documentation and evaluate the impact on small business.

Board member McCormick asked if it would be appropriate to submit a motion to send the packet to LCB

Board Member Baltazar asked if we could hear from schools.

Board Member Stanton stated that reading the comments seems to mean the Board needs to get details down and finalize the process.

Director Landry stated that after everything is submitted we will discuss the number of hours at the next Board meeting.

The Board voted to take the survey and submit it to LCB for review.

Jan Garrett DeSimone from the Clark County School district agreed that having some limited hands-on practice helps keep students engaged and with the technology today it's a possibility. Suggested that remote practical learning include entry-level skills, like a simple manicure, haircut, or blow-dry. 25-20 hours per week at 50/50 would be fair and support the students as they move forward.

Board Member Stanton requested a student survey to see how successful students feel online theory learning was during the pandemic.

In response to Board Member Stanton's comment, Board President Braimoh said she would like to see Board Staff put that together for when the students come in to take the test.

Jan Garret DeSimone suggested the result could be skewed depending on how the student(s) performed on the test, if they failed they would blame distance learning.

Board President Braimoh suggested a survey could be sent to new licensees.

Lu Suarez agreed with Jan Garret DeSimone and suggested that attendance was a more accurate measurement. The survey would be inaccurate for so many reasons including that not everyone graduates and takes the test right away.

DAG Taruc recommended this not be discussed until it was put on the next Board meeting agenda.

Board President Braimoh stated she wants to see it on the next Board meeting agenda and that there needs to be some type of survey to be able to show the legislature how it impacts the industry.

NOTICE IS HEREBY GIVEN that the Nevada State Board of Cosmetology will hold a public hearing at 9:00 a.m. on March 7, 2022, via ZOOM. The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations that pertain to Chapter 644A of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603.

Statement of need for and purpose of the proposed regulation or amendment:

The purpose of the regulation is to allow cosmetology students to earn practical hours remotely, outside of a licensed school of cosmetology, in times of "emergency" as declared by Nevada's Governor and upon a majority vote by the Board. Any remote practical learning would be limited to work on mannequins. This regulation amendment would allow for students to continue to earn practical hours when schools are closed or have limited capacity due to a governor-declared emergency.

Terms or substance of the proposed regulation or subjects and issues involved:

The proposed regulation seeks to modify the language of NAC 644A.618 which notes that students shall not practice at home or in a cosmetological establishment and shall not give demonstrations other than those required by them by their school of cosmetology. The proposed modification would add a subsection that notes that during a state of emergency or declaration of disaster as proclaimed by the Governor or by resolution of the Legislature, the Board may, by vote, authorize students to complete practical hours at home provided those hours are earned while working on a mannequin and not a live person. The full text of the proposed regulation is attached to this agenda and can be found on the Board's website, nvcosmo.com.

Estimated economic effect on business and public:

- (a) The survey results indicated that the majority of those polled felt that a proposed regulation change would not, directly or indirectly, negatively impact their businesses.
- (b) The Board does not foresee any adverse or beneficial effects both in the immediate and long-term on members of the public.

Estimated cost to the agency for enforcement:

The Nevada State Board of Cosmetology does not foresee there being a cost to enforce these proposed changes.

Overlap or duplication of regulations:

The proposed regulation does not include provisions that duplicate or are more stringent than federal, state, or local standards regulating the same activity.

Regulation required by federal law:

This regulation is not required by federal law.

More stringent than federal regulation:

The proposed regulation is not more stringent than a federal regulation that regulates the same activity.

There were no public comments made in opposition to the proposed modifications.

PROPOSED REGULATION OF THE STATE OF NEVADA BOARD OF COSMETOLOGY

SMALL BUSINESS IMPACT STATEMENT

This statement was prepared to comply with NRS 233B.0608 and NRS 233B.0609. This statement addresses the fiscal impact of proposed regulation change.

To determine whether this regulation change is likely to have an impact on small businesses, the Board of Cosmetology considered the purpose and scope of the proposed and potential regulations in conjunction with existing regulations. Based on this review, the Board of Cosmetology determined that the listed proposed regulation is not likely to have an adverse effect on small businesses.

The Board of Cosmetology does not anticipate that adopting the regulation will have any adverse effects or beneficial economic effects, either immediate or long-term on small businesses such as schools of cosmetology.

A. Description of the manner in which comment was solicited from affected small businesses, a summary of their responses, and an explanation of the manner in which other interested persons may obtain a copy of the summary.

The Nevada State Board of Cosmetology requested input from school owners and operators. A Typeform survey was sent to each of Nevada's licensed cosmetology schools asking for input as to the projected adverse and beneficial impacts of a proposed regulation change.

At the time this survey was sent, the Nevada State Board of Cosmetology licensed sixteen (16) schools of cosmetology. The Board of Cosmetology received twelve (12) survey responses. The representative from Milan institute responded on behalf of the Milan locations in both Reno and Las Vegas. The school representative from Expertise Cosmetology Institute submitted responses on behalf of both Expertise locations. The final, licensed school of cosmetology is located within the Florence McClure Women's Correctional Center and is a branch of Expertise Cosmetology Institute. One licensed school did not submit a response.

Response Summary:

B. The manner in which the analysis was conducted.

Surveys were sent to each of Nevada's licensed cosmetology schools along with an email explaining the purpose of the survey. In addition to the open-ended comment section at the end of the survey, school owners/operators were asked whether they anticipated any direct or indirect economic benefits or adverse effects upon their businesses. Survey participants were able to select "yes", "no" or "unknown" as their response.

Board staff reviewed the "yes" responses for schools that indicated that a regulation change was likely to have a negative impact on their business'. Any "yes" response was compared to the open-ended comment response at the end of the survey to determine the specific concerns of the individual school.

- C. The estimated economic effect of the proposed regulation on the small businesses which it is to regulate including, without limitation
 - a. Both adverse and beneficial effects; and
 - b. Both direct and indirect effects.

The proposed amendment would allow for schools to utilize remote practical learning in times of emergency, as declared by the Governor and upon majority vote of the Board of Cosmetology.

Survey results indicated that the majority of those polled felt that a proposed regulation change would not, directly or indirectly, negatively impact their businesses.

Under the proposed regulation, even during times of Governor declared emergency and upon majority vote, the decisions to utilize remote practical learning would be left up to the individual schools.

D. A description of the methods that the agency considered to reduce the impact of the proposed regulation on small businesses and a statement regarding whether the agency actually used any of those methods.

The majority of the schools polled did not believe that their school would be adversely impacted by the proposed regulation change. Four responses indicated that they felt the proposed regulation would have an adverse effect. Two of those four schools provided no open-ended response elaborating on their position, one school noted that it felt the quality of the student education may suffer with remote

distance learning and the fourth school indicated it approved of remote practical learning in times of emergency.

Any school that feels this regulation change would cause a direct or indirect burden would have the option not to offer remote practical learning.

E. The estimated cost to the agency for enforcement of the proposed regulation.

The Nevada State Board of Cosmetology does not anticipate there being a cost to enforce the proposed regulation.

F. If the proposed regulation provides a new fee or increases an existing fee, the total annual amount the agency expected to collect, and the manner in which the money will be used.

The proposed regulation does not provide for a new fee or increase an existing fee.

G. If the proposed regulation includes provisions which duplicate or are more stringent than federal, state or local standards regulating the same activity, an explanation of why such duplicative or more stringent provisions are necessary.

The proposed regulation does not include provisions which duplicate or are more stringent than federal, state or local standards regulating the same activity.

H. The reasons for the conclusions of the agency regarding the impact of the regulation on small businesses.

The Nevada State Board of Cosmetology has concluded that a regulation change allowing for remote practical learning during times of Governor declared emergency and upon majority vote of the Board does not create a significant economic impact on small businesses, specifically schools of cosmetology.

This regulation change would only have an impact during times of emergency and any school that does not wish to offer remote practical learning would not be required to do so.

I certify that, to the best of my knowledge or belief, a concerted effort was made to determine the impact of the proposed regulation on small businesses and that the information contained in the statement is accurate.






