## INFORMATIONAL STATEMENT OF ADOPTED REGULATION AS REQUIRED BY ADMINISTRATIVE PROCEDURES ACT, NRS 233B.066 LCB FILE NO. R021-21

The following statement is submitted for adopted amendments to the Nevada Administrative Code (NAC) Chapter 624 in compliance with NRS 233B.066.

**1. A clear and concise explanation of the need for the adopted regulation.**

The proposed regulation amends NAC 624.590 to grant credit toward the satisfaction of a portion of experience requirement for licensure to applicants who have completed certain occupational and vocational training programs as provided for in Assembly Bill 330 passed during the 2021 legislative session. The regulation also makes minor changes to NAC 624.640 related to display of license certificates and repeals NAC 624.678 in regards to duplicate licenses.

**2. A description of how public comment was solicited, a summary of the public response and an explanation of how other interested persons may obtain a copy of the summary.**

The notice of workshop and notice of hearing to solicit comments on the proposed regulation was posted on the agency's website and on the Nevada Public Notice Website, State Library and Archives, Nevada Register and both offices of the Nevada State Contractors Board. Additionally, the notice of workshop and hearing, and the proposed regulation were e-mailed electronically to approximately 456 individuals and organizations who have expressed interest in being kept informed of the Board's meetings. Public comment was solicited in the notice of workshop and the notice of hearing which included the proposed regulation and small business impact statement.

Public comment was also solicited at the workshop held on January 6, 2022 and at the hearing held on January 13, 2022 and the Board Meeting held on January 20, 2022. The public workshop and hearings took place via Zoom. No public comments were received.

The regulation was adopted without changing any part of the proposed regulation since no public comment was received at the workshop or hearing and no written comments were received by the agency.

**7. The estimated economic effect of the regulation on the business which it is to regulate and on the public.**

**A) Estimated economic effect on the businesses which they are to regulate.**

The regulation should not result in any adverse economic effect in either the immediate term or in the long term on businesses in which they regulate. Immediate and long-term beneficial effects upon the business that the regulation regulate include an expansion of qualifying experience for a contractor's license as well as an elimination of burdens on business.
