Informational Statement LCB File No. R118-21

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 630.

1. A Clear and Concise Explanation of the Need for the Adopted Regulation.

The proposed regulation is necessary to update existing regulations to be consistent with other provisions of law, to clarify existing requirements in the law, to add to the provisions regarding the Board's advisory committees, and to repeal regulations that are no longer needed and/or duplicate other provisions of law.

A regulation workshop on LCB File No. R118-21 was held on April 27, 2022, at1:30 p.m., at the Las Vegas Office located at 325 E. Warm Springs Road, Suite 225, Las Vegas, NV 89119. This public workshop was video conferenced to the Board's Reno office located at 9600 Gateway Drive, Reno, NV 89521. No members of the public attended the regulation workshop.

A public hearing on LCB File No. R118-21 was held on May 10, 2022, at 2:00 p.m., at the Board's Las Vegas office located at 325 E. Warm Springs Road, Suite 225, Las Vegas, NV 89119.

This public hearing was video conferenced to the Board's Reno office located at 9600 Gateway Drive, Reno, NV 89521. Three members of the public (physician assistants) signed in for the May 10, 2022 public hearing, talked with Deputy Executive Director Bradley regarding the proposed regulations, and left before the public hearing began. (c) Submitted to the Agency Written Comments:

Written comment was received from three physician assistants, Janet Wheble, Amie Duford, and Jessica Radivan prior to the regulation workshop held on April 27, 2022. The written comment received addressed both LCB File No. R171-20 and LCB File No. R118-21. The written comment indicates support for the number of physician assistants recommended for the physician assistant advisory committee. Note: This number is not changed in these proposed regulations. The written comment requests the ability to serve for multiple four-year terms as a member of the physician assistant advisory committee members. Note: Proposed regulation LCB File No. R118-21 creates a four-year term for physician assistant members of the physician assistant advisory committee. It does not prohibit members from serving more than one term on the committee. The written comment requests the Board consider allowing a maximum of two terms on the physician assistant advisory committee, for a total of eight years. Note: Proposed regulation LCB File No. R118-21 does not currently address this and a new regulation change would be needed to impose a maximum number of terms and years for members to serve on the physician assistant advisory committee. The written comment supports the update to the requirement of a graduate degree for a physician assistant and removing high school diploma as an option to qualify for licensure. The written comment requests that the Board notify individuals licensed as physician assistants without postgraduate degrees that if they let their licenses lapse for any reason, they would no longer qualify for licensure. The written comment also offers to provide any assistance to the Board with regard to the Board's regulations.

No public comment was received at the regulation workshop or public hearing. Written comment was received from three physician assistants, Janet Wheble, Amie Duford, and Jessica Radivan prior to the regulation workshop held on April 27, 2022. The written comment received addressed both LCB File No. R171-20 and LCB File No. R118-21. The written comment was received prior to the regulation workshop and read into the record for that meeting. That written comment did not indicate that a small business would be affected by these proposed regulations. This regulation was adopted by the Board at a public meeting held on June 10, 2022. It was adopted without changes because no comments or suggested changes were received.

The Board does not believe that the proposed regulation will have an immediate or long-term direct economic effect on the business of the practice of medicine, nor will it have a direct economic effect on the public.
