The purpose of the hearing is to receive comments from all interested persons regarding the adoption of a regulation pertaining to Chapter 634A of the Nevada Administrative Code, LCB File No. R026-22. The following information is provided pursuant to the requirements of NRS 233B.0603:

**1. The need for and the purpose of the proposed regulation.**

The need for and the purpose of the proposed regulation is to protect the public health, safety and welfare by ensuring that only qualified and competent Oriental Medicine Doctors are licensed in the state. The purpose of the adopted regulation is to provide clarity for the public, individuals and licensees through regulations.

The proposed regulation changes are listed below:

Existing law requires each applicant for a license to practice as a doctor of Oriental medicine to pass: (1) each examination required and administered by the National Certification Commission for Acupuncture and Oriental Medicine or its successor organization for certification in Oriental medicine; and (2) an examination approved by the State Board of Oriental Medicine that tests the applicant's knowledge and understanding of the laws and regulations of this State relating to health and safety in the practice of Oriental medicine. (NRS 634A.120) Existing regulations require that an applicant for a license to practice as a doctor of Oriental medicine must have passed the examinations administered by the Commission within the 12 months preceding the date of application for licensure or be certified by the Commission or its successor organization. Existing regulations also: (1) require the Board to give the practical examination in June and December of each year; (2) set forth the subjects that may be included in the practical examination; (3) require an applicant to receive an overall score of at least 70 percent and 65 percent on each of its sections or subparts to pass the practical examination; and (4) provides that an applicant who failed only one section of the practical examination will be reexamined only with respect to the section that he or she failed. (NAC 634A.085, 634A.100, 634A.110) **Section 2** of this regulation defines the term "national examination" to mean each examination required and administered by the National Certification Commission for Acupuncture and Oriental Medicine or its successor organization for certification in Oriental medicine. **Section 3** of this regulation defines the term "state examination" to mean the examination approved by the Board that tests the applicant's knowledge and understanding of the laws and regulations of this State relating to health and safety in the practice of Oriental medicine, and this term replaces the term "practical examination." **Section 4** of this regulation makes a conforming change to indicate the proper placement of **sections 2 and 3** within the Nevada Administrative Code, and **sections 5, 7-10 and 15** of this regulation make conforming changes to reflect the changes in terminology. **Section 7** of this regulation eliminates the requirement that an applicant for licensure as a doctor of Oriental medicine must pass the examinations administered by the Commission within the 12 months preceding the date of the application for licensure or be certified by the Commission or its successor organization. **Section 9** of this regulation: (1) authorizes the Board to give additional state examinations at any time the Board may designate; (2) revises the list of subjects that may be included in the state examination; and (3) eliminates the requirement that an applicant must receive a score of at least 65 percent on each of the sections or subparts of the state examination. **Section 10** of this regulation eliminates the requirement that an applicant who failed only one section of the state examination will be reexamined only with respect to the section that he or she failed.

Existing law requires the Board to issue a license to practice as a doctor of Oriental medicine to an applicant who, among other requirements, has successfully completed a 4-year program of study, or its equivalent, in Oriental medicine at a school or college of Oriental medicine that is approved by the Board. (NRS 634A.090, 634A.140) Existing regulations set forth the requirements for the Board to approve a 4-year program of study, or its equivalent, in Oriental medicine, which include, among other requirements: (1) training or instruction in certain subjects; and (2) that a student graduate on or after November 25, 2002 having completed at least 3,000 hours of instruction, including not less than 2,500 didactic hours. (NAC 634A.080) **Section 6** of this regulation adds that a program of study that results in a combined bachelor's and master's degree in Oriental medicine is sufficient to satisfy the requirement that a student

who graduates on or after November 25, 2002, must complete at least 3,000 hours of instruction, including not less than 2,500 didactic hours.

Existing law requires an applicant for the renewal of a license to practice as a doctor of Oriental medicine to complete certain requirements for continuing education. (NRS 634A.167) Existing regulations authorize a licensee who earns more than 10 hours of credit for continuing education in any calendar year to carry forward up to 10 hours of excess credit and apply such excess credit to the educational requirements for the next calendar year if the licensee indicates in writing, at the time he or she submits the form for renewal of his or her license, that the licensee intends to carry forward such excess credit. (NAC 634A.135) **Section 11** of this regulation eliminates the requirement that a licensee indicate in writing at the time he or she submits the form for renewal of his or her license that the licensee intends to carry forward any such excess credit.

Existing regulations prohibit a person or entity from offering a course of continuing education for licensees in this State unless prior approval for the course has been obtained from the Board. (NAC 634A.137) **Section 12** of this regulation authorizes certain courses which are approved for recertification by the National Certification Commission for Acupuncture and Oriental Medicine to be offered as courses of continuing education for licensees in this State without prior approval by the Board and exempts such courses from the imposition of fees for the approval of courses of continuing education.

Existing regulations provide that the Board will prorate by the month the annual fee for the first renewal of an active or inactive license to practice Oriental medicine. (NAC 634A.140) **Section 13** of this regulation instead provides that a holder of a license is not required to pay the annual fee for the first renewal of an active or inactive license until February 1 of the year following the year in which the license was issued.

Existing regulations set forth the requirements for the reinstatement of a license to practice Oriental medicine that has been cancelled and require a person whose license has been cancelled to comply with the requirements within 1 year after cancellation or reapply for a new license. (NAC 634A.150) **Section 14** of this regulation instead requires a person whose license has expired to comply with the requirements within 90 days after expiration or reapply for a new license. **Section 15** of this regulation makes conforming changes to the fees charged by the Board. **Section 15** also eliminates the fees charged by the Board for transfers of licenses between active status and inactive status. **Section 16** of this regulation: (1) authorizes the payment of fees and remittances to the Board by credit card or debit card; and (2) provides that the Board will not refund any original or reexamination fee for the state examination or any renewal fee for an active or inactive license.

Existing regulations require certain applicants for a license to practice Oriental medicine to pass the Test of English as a Foreign Language Paper-Based Test or the Test of English as a Foreign Language Internet-Based Test and to demonstrate a reasonable proficiency in the English language through an oral interview at the time of the practical examination. (NAC 634A.095) **Section 17** of this regulation eliminates these requirements.

Existing regulations prohibit a holder of a license to practice Oriental medicine from operating under a fictitious name unless the licensee complies with certain requirements, including the submission of an application and fee to the Board. (NAC 634A.121) **Section 17** eliminates that prohibition. **Section 15** makes a conforming change to the fees charged by the Board.

The Board solicited comments with the Small Business Impact Study form to its licensees and requestors as well as held a public workshop on 4/5/2022. There were 2 comments but they were unrelated to any impact on small businesses.

There will be no significant cost to the Nevada State Board of Oriental Medicine for enforcement of the proposed regulation.

A REGULATION relating to Oriental medicine; revising requirements for the proof of qualification of an applicant for licensure to practice Oriental medicine; revising provisions relating to the examinations of an applicant for a license to practice Oriental medicine; revising provisions relating to continuing education requirements; providing that certain courses approved by the National Certification Commission for Acupuncture and Oriental Medicine may be offered as courses for continuing education without approval from the Board; revising provisions relating to the renewal of a license to practice Oriental medicine; authorizing the payment of fees to the Board by credit card or debit card; eliminating the requirement that certain applicants for a license to practice Oriental medicine must pass certain English proficiency tests and demonstrate a reasonable proficiency in the English language during an oral interview at the practical examination; eliminating provisions relating to a licensee operating under a fictitious name; eliminating certain fees; and providing other matters properly relating thereto.

(NAC 634A.095) **Section 17** of this regulation eliminates these requirements.

Existing regulations prohibit a holder of a license to practice Oriental medicine from operating under a fictitious name unless the licensee complies with certain requirements, including the submission of an application and fee to the Board. (NAC 634A.121) **Section 17** eliminates that prohibition. **Section 15** makes a conforming change to the fees charged by the Board.

**Section 1.** Chapter 634A of NAC is hereby amended by adding thereto the provisions set forth as sections 2 and 3 of this regulation.

**Sec. 2.** *“National examination” means the examination required by paragraph (a) of subsection 1 of NRS 634A.120.*

**Sec. 3.** *“State examination” means the examination required by paragraph (b) of subsection 1 of NRS 634A.120.*

**Sec. 4.** NAC 634A.001 is hereby amended to read as follows:

634A.001 As used in this chapter, unless the context otherwise requires, the words and terms defined in NAC 634A.002 to 634A.008, inclusive, *and sections 2 and 3 of this regulation* have the meanings ascribed to them in those sections.

**Sec. 5.** NAC 634A.071 is hereby amended to read as follows:

634A.071 1. A person who desires to be licensed by the Board as a doctor of Oriental medicine must, at least 3 months before the date of the ~~practical~~ *state* examination in which the person wishes to participate:

(a) File an application with the Executive Director;

(b) Pay to the Board at the time of filing his or her application any applicable fees set forth in NAC 634A.165; and

(c) Submit any other documentation or proof that the Board may require.

2. The application must be:

(a) Made on the form provided by the Board; and

(b) Typed or written in English.

3. The application must include:

- (a) The social security number of the applicant;
- (b) A set of the fingerprints of the applicant, together with written consent for the Board to submit the fingerprints to any law enforcement agency in connection with his or her application;
- (c) Written consent of the applicant to an investigation of his or her personal background, professional training and experience by the Board or any person acting on its behalf; and
- (d) Evidence that the applicant possesses the qualifications required pursuant to this chapter and chapter 634A of NRS for licensure as a doctor of Oriental medicine.

**Sec. 6.** NAC 634A.080 is hereby amended to read as follows:

634A.080 1. An applicant for a license to practice Oriental medicine must submit, together with his or her application, evidence that he or she has successfully completed a 4-year program of study, or its equivalent, in Oriental medicine at a school or college of Oriental medicine which is approved by the Board.

2. If the application is submitted pursuant to subsection 1 of NRS 634A.140, the applicant must submit evidence showing that he or she has earned a bachelor's degree from an accredited college or university in the United States.

3. If the application for licensure by endorsement is submitted pursuant to subsection 2 of NRS 634A.140, the applicant must submit evidence that he or she:

(a) Has lawfully practiced Oriental medicine in another state or foreign country for at least 4 years; and

(b) Holds Oriental Medicine Certification by the National Certification Commission for Acupuncture and Oriental Medicine or its successor organization.

4. For the purposes of subsection 1, the Board may approve a 4-year program of study, or its equivalent, in Oriental medicine at a school or college of Oriental medicine if the Board finds that:

(a) The school or college of Oriental medicine is:

(1) Accredited by the Accreditation Commission for Acupuncture and Oriental Medicine or its successor organization; or

(2) In pre-accreditation status with the Accreditation Commission for Acupuncture and Oriental Medicine or its successor organization and satisfies the requirements of paragraph (b).

(b) The program of study includes training or instruction in the subjects of acupuncture, moxibustion, herbology, Oriental physiology, Oriental pathology, Oriental diagnosis, tuina or qigong, biology, chemistry or biochemistry, anatomy, Western physiology, Western pathology, Western diagnosis ~~and~~ pharmacology . ~~laboratory and radiology.~~ **laboratory and radiology.**

(c) The program of study:

(1) Required the completion of at least 2,800 hours of instruction, including not less than 2,500 didactic hours, for a student to have graduated before November 25, 2002; or

(2) Requires the completion of at least 3,000 hours of instruction, including not less than 2,500 didactic hours, for a student to graduate on or after November 25, 2002 ~~and~~, *or results in the award of a combined bachelor's and master's degree in Oriental medicine to a student who graduates on or after November 25, 2002.*

*(3) A combined Bachelor's Master's degree in Oriental Medicine degree is considered sufficient to satisfy paragraph 2.*

5. For the purposes of subsection 1, the Board will deem a master's degree to be the equivalent of a 4-year program of study if the program of study for the degree conforms to the requirements of paragraphs (b) and (c) of subsection 4.

6. For the purposes of subsections 2 and 3, evidence that the applicant is qualified for licensure as a doctor of Oriental medicine must include certified copies of any diplomas, transcripts, licenses and certificates issued to the applicant. If possible, all certified copies of official diplomas, transcripts, licenses or certificates must be forwarded directly to the Executive Director from the issuing entity rather than from the applicant.

4. The ~~practical~~ *state* examination will be given in written form. Each applicant shall take the examination in the English language.

5. An applicant must receive ~~{an overall}~~ a score of *at least* 70 percent ~~{on the practical examination and 65 percent on each of its sections or subparts}~~ to pass the *state* examination.

(c) The fee required pursuant to NAC 634A.165.

4. If the Board approves a course of continuing education pursuant to this section, the Board will determine the number of hours of continuing education that a licensee may receive for attending the course.

5. Board approval of a course of continuing education other than a course described in subsection 2 expires 4 years after that approval.

**634A.095 Proficiency of applicant in English language. (NRS 634A.070, 634A.120)**

1. Except as otherwise provided in subsection 2, an applicant for a license to practice

Oriental medicine must:

(a) Before taking the practical examination:

(1) Pass the Test of English as a Foreign Language Paper-Based Test with a score of at least 550; or

(2) Pass the Test of English as a Foreign Language Internet-Based Test with a total score of at least 80; and

(b) At the time of the practical examination, demonstrate a reasonable proficiency in the English language through an oral interview.

2. Subsection 1 does not apply to an applicant who graduated from a high school or college in the United States.

**634A.121 Practice under fictitious name; prohibition against multiple licenses and registration under same name. (NRS 634A.070)**



1. A licensee shall not operate under a fictitious name unless the licensee complies with chapter 602 of NRS and files with the Board a certified copy of the certificates issued by the county clerk.

2. Any licensee who wishes to practice under a fictitious name must submit to the Board an application, on a form provided by the Board, accompanied by a fee of \$50.

3. The Board will not issue more than one license or register more than one licensee under the same name.
