**Regulatory Workshop-NAC 634A Revised Proposed Regulation (LCB File-R026-22)**

**1. Introduction-Open Public Workshop**

The purpose of the workshop is to receive comments from all interested persons regarding the potential adoption of regulations that pertain to chapter 634A of the Nevada Administrative Code. Public comments will be limited to 3 minutes per person and must

be directly related to the proposed regulation topics. Interested parties are strongly encouraged to submit comments in writing prior to the Workshop.

Proposed new or revised sections are stated below:

NAC 634A.080 Evidence of qualifications of applicant; approval of program of study deletes laboratory and radiology requirements and allows a combined Bachelors/Masters degree to be considered sufficient.

NAC 634A.085 Compliance with requirement of passing examination administered by national organization deletes the timeframe requirement for obtaining the NCCAOM Oriental Medicine Certification.

NAC 634A.095 Proficiency of applicant in English language is deleted.

NAC 634A.100 Practical examination of applicant; subjects included in examination deletes certain subject areas, deletes passing scores on exam sections, and adds ethics to the state exam.

NAC 634A.110 Reexamination of applicant who fails practical examination deletes failure of exam sections.

NAC 634A.121 Practice under fictitious name; prohibition against multiple licenses and registration under same name is deleted.

NAC 634A.135 Continuing education NCCAOM designations are expanded, and carryover credits writing requirement is deleted.

NAC 634A.140 Payment of annual renewal fee is defined and proration of fee is deleted.

NAC 634A.150 Reinstatement of license cancelled for failure to pay annual fee is amended to be consistent with NRS 634A.167.

NAC 634A.165 Certain fees of Board are deleted and fee language is amended to allow for flexibility.

NAC 634A.230 Language is added that allows for credit cards and debit cards, and that state exam fees, renewal fees and inactive fees are non-refundable.

## **2. Public Comment**

No vote may be taken upon a matter raised during a period devoted to public comment until the matter itself has been specifically included on an agenda as an item upon which action may be taken. (NRS 241.020)

## **3. Close Public Workshop.**

Public comment is welcomed by the Board. Public comment will be limited to 3 minutes per person and comments based upon viewpoint will not be restricted. Public comment will be available prior to action items on the agenda and on any matter not specifically included on the agenda as the last item on the agenda. At the discretion of the Chairperson, additional public comment may be heard when that item is reached. The Chairperson may allow additional time to be given to a speaker as time allows and in his/her sole discretion. (NRS 241.020, NRS 241.030)

Prior to the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the Board may refuse public comment. (NRS 233B.126)

---
