## INFORMATIONAL STATEMENT OF ADOPTED REGULATION AS REQUIRED BY ADMINISTRATIVE PROCEDURES ACT, NRS 233B.066 LCB FILE NO. R034-22

The following statement is submitted for adopted amendments to the Nevada Administrative Code (NAC) Chapter 624 in compliance with NRS 233B.066.

**1. A clear and concise explanation of the need for the adopted regulation.**

NRS 624.220 authorizes the board to adopt regulations necessary to affect the classification and subclassification of contractors in a manner consistent with established usage and procedure as found in the construction business and to set limits on the field and scope of the operations of a contractor as may be necessary to protect the health, safety and general welfare of the public.

A need was identified to provide an opportunity for licensure to companies that solely perform residential remodeling work and who may not have the experience or the desire to construct residential and small commercial buildings as provided for in the B2-Residential & Small Commercial classification.

**2. A description of how public comment was solicited, a summary of the public response and an explanation of how other interested persons may obtain a copy of the summary.**

The notice of workshop and notice of hearing to solicit comments on the proposed regulation was posted on the agency's website and on the Nevada Public Notice Website, State Library and Archives, Nevada's Regulation Notices website and both offices of the Nevada State Contractors Board. Additionally, the notice of workshop and hearing, and the proposed regulation were e-mailed electronically to approximately 444 individuals and organizations who have expressed interest in being kept informed of the Board's meetings. Public comment was solicited in the Notice of Workshop and Hearing which included the proposed regulation and small business impact statement.

Public comment was also solicited at the workshop held on May 26, 2022, at the hearing held on June 2, 2022 and the Board Meeting held on June 16, 2022 which all took place at the office of the Board at 8400 West Sunset Road, Suite 150, Las Vegas, NV and 5390 Kietzke Lane, Suite 102, Reno, Nevada 89511. **6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.**

The regulation was adopted without changing any part of the proposed regulation since no public comment was received at the workshop or hearing and no written comments were received by the agency.

**7. The estimated economic effect of the regulation on the business which it is to regulate and on the public.**

**A) Estimated adverse and beneficial effects on the businesses which they are to regulate.**

The regulation should not result in any adverse economic effect on businesses in which they regulate. The benefit of the regulation will be to provide an opportunity for licensure to companies that solely perform residential remodeling work and who may not have the experience or the desire to construct residential and small commercial buildings as provided for in the B2-Residential & Small Commercial classification.

**B) Estimated immediate and long-term effects.**

The regulation should not result in any adverse economic effect on the general public. The regulation presents both positive immediate and long-term effects. The positive effects are that a residential remodeling category would provide a pathway for licensure for the sector of the industry by limiting the scope of practice and providing for smaller scale projects.

The proposed regulation will not result in any cost to the agency.
