

**ADOPTED REGULATION OF THE  
NEVADA INTERSCHOLASTIC ACTIVITIES ASSOCIATION**

**LCB File No. R040-22**

AUTHORITY: §§ 1-3, NRS 385B.060.

A REGULATION relating to interscholastic activities; increasing the number of nonvoting and voting members of the Board of Control of the Nevada Interscholastic Activities Association; authorizing pupils and parents or guardians of pupils who participate in a sanctioned sport to serve on the Board; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

Existing law authorizes the county school district trustees to form a nonprofit association, to be known as the Nevada Interscholastic Activities Association, for the purposes of controlling, supervising and regulating all interscholastic athletic events and other interscholastic events in the public schools. (NRS 385B.050) Section 1 of Assembly Bill No. 105 of the 81st Session of the Nevada Legislature requires: (1) any board formed to govern the Association to include parents or guardians of pupils who participate in a sanctioned sport from certain counties; and (2) any advisory board formed to advise a governing board of the Association to include pupils currently participating in a sanctioned sport from certain counties. (NRS 385B.050)

Existing regulations create the Board of Control as the governing body of the Association and prescribe the voting and nonvoting membership of the Board. (NAC 385B.106) **Section 1** of this regulation increases the number of nonvoting members of the Board by adding three representatives who are pupils who are currently participating in a sanctioned sport from certain counties. **Section 2** of this regulation increases the number of voting members of the Board by adding three representatives who are parents or guardians of pupils who participate in a sanctioned sport from certain counties. **Section 3** of this regulation makes a pupil who participates in a sanctioned sport, or the parent or guardian of such a pupil, eligible for membership on the Board if the pupil, parent or guardian is not an employee of a school district, charter school or private school or the child or immediate family member of such an employee.

**Section 1.** NAC 385B.106 is hereby amended to read as follows:

385B.106 1. The Board consists of ~~nine~~ *twelve* voting members selected ~~from the administrative regions established~~ pursuant to NAC ~~385B.104.~~ *385B.110*. The Board is the governing body of the Association.

2. In addition to the voting members specified in subsection 1, the Board includes the following nonvoting members:

(a) The president of:

- (1) Each class established pursuant to NAC 385B.250;
- (2) The private schools selected pursuant to NAC 385B.240; and
- (3) The Nevada Athletic Directors Association or its successor organization;

(b) A representative from Class 4A North who is not serving as a nonvoting member pursuant to subparagraph (1) of paragraph (a);

(c) A representative from Class 4A South who is not serving as such a nonvoting member;

(d) A representative appointed by the Nevada Association of School Administrators or its successor organization;

(e) A representative appointed by an association of sports officials approved by the Association; ~~and~~

(f) A representative from a charter school that is a member school ~~H~~; *and*

*(g) Three pupils who are currently participating in a sanctioned sport of the Association to include:*

*(1) A resident of a county whose population is 700,000 or more;*

*(2) A resident of a county whose population is at least 100,000 but not more than 700,000; and*

*(3) A resident of a county whose population is less than 100,000.*

*↪ Of the three members selected pursuant to this paragraph, none may be a child or immediate family member of an employee of a school district, charter school or private school.*

3. Each nonvoting member specified in subsection 2 serves for a term of 2 years.

**Sec. 2.** NAC 385B.108 is hereby amended to read as follows:

385B.108 1. The voting membership of the Board is as follows:

(a) Two representatives from Administrative Region I, which consists of Washoe County;

(b) One representative from Administrative Region II, which consists of Carson City and Churchill and Douglas counties;

(c) One representative from Administrative Region III, which consists of Elko, Esmeralda, Eureka, Humboldt, Lander, Lincoln, Lyon, Mineral, Nye, Pershing, Storey and White Pine counties; ~~and~~

(d) Five representatives from Administrative Region IV, which consists of Clark County ~~H~~;  
*and*

*(e) Three representatives who are parents or guardians of a pupil who participates in a sanctioned sport and include:*

*(1) A resident of a county with a population of 700,000 or more;*

*(2) A resident of a county with a population of at least 100,000 but not more than 700,000; and*

*(3) A resident of a county with a population of less than 100,000.*

*↪ Of the three members selected pursuant to this paragraph, none may be a child or immediate family member of an employee of a school district, charter school or private school.*

2. The President of the Board may vote on any item set forth on the agenda of the Board for which a vote is required.

**Sec. 3.** NAC 385B.110 is hereby amended to read as follows:

385B.110 1. Each school trustee and each person who is:

- (a) A superintendent of a school district;
- (b) An assistant or deputy superintendent of a school district;
- (c) A director of athletics of a school district; ~~for~~
- (d) A principal of a high school ~~H~~; *or*

*(e) A pupil who participates in a sanctioned sport or the parent or guardian of such a pupil, if the pupil, parent or guardian is not an employee of a school district, charter school or private school or a child or immediate family member of such an employee,*

↪ is eligible to be selected to serve as a member of the Board.

2. The school trustees of each administrative region established pursuant to NAC 385B.104 shall select the members of the Board from that region. The term of a selected member begins on July 1 after his or her selection. A member of the Board may be reselected.

3. If a vacancy occurs in the membership of the Board, the Executive Director shall notify the school trustees of the administrative region from which the vacant member was selected. An unexpired term of a member of the Board must be filled by the school trustees of the administrative region in which the vacancy occurs. Each member selected to fill a vacancy serves for the remainder of the unexpired term.

4. Except as otherwise provided in subsection 3, each voting member of the Board serves for a term of 3 years.
