## LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233B.066 PERMANENT REGULATIONS

The following statement is submitted for adopted amendments to the Nevada Administrative Code (NAC) Chapter 643.

1. A clear and concise explanation of the need for the adopted regulations.

These regulation changes are necessary to provide update language to the NAC codes of Chapter 643, and to make the NRS's clearer.

2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

Copies of the proposed regulations, notices of workshops, public hearing, and notices of intent to act upon the regulations were sent by U.S. Mail, faxes, and emails to persons who were known to have an interest. These documents were also made available at the website of the Nevada State Barbers' Health and Sanitation Board, <a href="www.barber.nv.gov">www.barber.nv.gov</a> they were posted at all county libraries in the State and they were posted at the following locations along with the Board's office in Las Vegas, the Board's office in Reno, Office of the Attorney General in Carson City, Office of the Attorney General in Las Vegas, the Nevada State Library and Archives and the Nevada Public Notices website.

The Board held several meetings on this to allow the public opportunities to be involved.

The Board held the first meeting /Public Workshop on October 17, 2021. This was to gather information from the interested parties on changes they would like to see changed. There were 5 individuals in attendance. They gave their input verbally. The Board took the opportunity to ask questions of them on what they felt would work better.

The Board held the second meeting on November 14, 2021 to start work on this project. There were 17 individuals present and there was no public comment.

The Board held the third meeting on February 6, 2022 to continue work on the project. There were 6 individuals present with no public comment.

The Board held a Public Workshop on March 6, 2022. To go over the proposed changes. There were 3 individuals in attendance. The only comments were questions they had that were answered.

The Board held the Public Hearing on January 8, 2023. To adopt the regulations. There were 3 individuals in attendance. There was no opposition on any of the changes.

A Small Business Impact survey was posted on the Board's website at <a href="www.barber.nv.gov">www.barber.nv.gov</a> on February 8, 2022 with the deadline for return being March 1, 2022. This survey was also posted in the same manner as the public workshop and the public meeting. It was posted at all county libraries in the State and they were posted at the following locations along with the Board's office in Las Vegas, the Board's office in Reno, Office of the Attorney General in Carson City, Office of the Attorney General in Las Vegas, the Nevada State Library and Archives and the Nevada Public Notices website. There was no response.
