INFORMATIONAL STATEMENT FOR ADOPTED PERMANENT REGULATION

NRS 233B.066

LCB FILE R169-22

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 634.

1. A clear and concise explanation of the need for the adopted regulation.

The purpose of the proposed regulation is to add new language and amend current provisions related to chiropractic physicians and chiropractor's assistants. New language was added to:

NAC 634 Section 1: This revision sets forth the documents an applicant may provide to the Board for the purposes of furnishing satisfactory evidence that he or she has a high school education.

2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

Copies of the proposed regulations, notices of workshop and notices of intent to act upon the regulation were sent via e-mail to all of the Board's licensees and chiropractic assistants who maintain an e-mail address with the Board, totaling 1,080. The Board also sent a copy of the proposed regulations, notice of workshop and notice of intent to act upon the regulation to the Nevada Chiropractic Association and Nevada Chiropractic Council, the trade associations that represents chiropractic physicians. A workshop was held regarding the regulations on July 14, 2022. Any person who desired to make comments regarding the regulations was invited to participate in the workshop. On November 17, 2022, the Board issued a Notice of Intent to Act Upon a Regulation which incorporated the proposed amendments and suggestions of the parties attending the meetings and workshops. On January 12, 2023 the Board conducted a hearing regarding the final language of the proposed regulation. No written comments were submitted prior to the hearing; however Dr. Dave Rovetti was present and spoke at the hearing. At the conclusion of the hearing, the Board announced its final determinations regarding the language of the regulation.

The permanent regulation was adopted on January 12, 2023 and included the changes, additions, and amendments suggested at the workshop, hearing, and the Board's Legislative Committee that were acceptable to the Board as being within the legislative intent of the empowering statutes (NRS 634.030(2)).

The regulations were not intended to and will not have adverse economic effects upon the practice of chiropractic in Nevada, however will make it easier for licensees to obtain licensure in Nevada.

The regulations were not intended to and will not have adverse economic effects upon the public. The public will benefit by having access to more chiropractic physicians since

(b) Both immediate and long-term effects.

The proposed regulations will have the same effects immediately and in the long-term on the practice of chiropractic in Nevada. These effects being that chiropractic physicians will be able to obtain licensure in an efficient manner.

The proposed regulations will have the same effects immediately and in the long-term on the Nevada public. The effects being that there will be access to more chiropractic physicians since the
