The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 502 and 488.

The proposed regulation would allow the Department authority to provide refunds on licenses and vessel products.

Public comment for the temporary regulation was solicited during one regulation workshop of the Nevada Board of Wildlife Commissioners (NBWC) on November 4, 2022. There was one public comment. Jacob Thompson representing Clark CABMW, asked what conditions would warrant a partial refund.
