

## **INFORMATIONAL STATEMENT FOR ADOPTED TEMPORARY REGULATION**

### **LCB FILE R072-15**

The following statement is submitted for permanent amendment to Nevada Administrative Code (NAC) Chapter 634.

**1. A clear and concise explanation of the need for the adopted regulation.**

*The purpose of the proposed regulation is to add new language to define the term “precisely controlled force” as that term is used in NRS 634.014.*

**2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.**

*At a meeting on May 31, 2014 the Board discussed the proposed new language to define “precisely controlled force.” At its September 6, 2014 meeting the Board voted to move forward with the proposed language to be added to NAC 634. There was no comment from the representative of the professional association who was present at both meetings and no other members of the public were present.*

*On October 27, 2014 the CPBN’s intent to consider the potential addition to NAC Chapter 634 was published on the agenda for a Workshop to be held on November 11, 2014. Any person who desired to make comments regarding the regulation was invited to participate in the workshop. Copies of the November 11, 2014 Notice of Public Workshop to Consider the Proposed Regulation Change, the Proposed Regulation Change and the Small Business Impact Statement were e-mailed to all licensees whose e-mail addresses are registered with the CPBN, and were mailed to the licensees, professional association, and Nevada county libraries on the CPBN’s mailing list. A total of 1,172 people or organizations received the documents. No Small Business Impact Statement responses were received. No written comments were received. No representatives of the profession or the public attended the November 11 Workshop.*

*On or before December 9, 2014 a Notice of Intent to Act Upon a Proposed Temporary Regulation on January 10, 2015 was e-mailed to all licensees whose e-mail addresses are registered with the CPBN, and were mailed to the licensees, professional association, and Nevada county libraries on the CPBN’s mailing list. One written response was received from the professional association in support of the proposed regulation, and no responses were received from individual members of the profession or the public.*

*The November 11, 2014 Notice of Public Workshop to Consider the Proposed Regulation Change and the January 10, 2015 Notice of Intent to Act Upon a Proposed Temporary Regulation were also posted at the following locations:*

*On January 10, 2015 the Board conducted a hearing regarding the final language of the proposed regulation, which at that time would be a temporary regulation. The written communication from the professional association was considered. The representative of the professional association who was present at the hearing provided testimony fully stating his views and concerns regarding the proposed temporary regulation. At the conclusion of the hearing, the Board announced its final determination regarding the language of the proposed temporary regulation.*

*On March 5, 2016 the Board conducted a hearing regarding the final language of the proposed regulation, which at this hearing was a hearing for the permanent adoption of the Regulation. No public comment, either written or oral, was provided. The Board adopted the proposed language as a permanent regulation.*

*There were no comments received at the workshop. The comments received at the hearing were from a representative of the professional association and were accepted. There were no comments received at the hearing regarding the adoption of the permanent regulation. Other interested persons may obtain a copy of the comments received by contacting the CPBN's Executive Director.*

- 6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation with change.**

*The temporary regulation, which included the change proposed by the Nevada Chiropractic Association, was adopted on January 10, 2015. The deletion suggested in written and verbal form from the representative of the professional association was acceptable to the Board as being within the legislative intent of the empowering statutes (NRS 634.030(2)). The change was not substantive.*

*There are no anticipated adverse or beneficial economic effects on the chiropractic profession or the public.*
