The standing committees of the Assembly are presumed to have jurisdiction over bills affecting certain titles and chapters of *Nevada Revised Statutes* (NRS), except where referrals to other committees apply or the Speaker of the Assembly determines that another referral is appropriate.

1. **The Committee on Commerce and Labor** has jurisdiction over measures affecting primarily the following Titles and Chapters of NRS, **except measures affecting state and local revenue, which are to be referred to the Committee on Taxation.**

2. **The Committee on Constitutional Amendments** has jurisdiction over measures proposing to amend the *Constitution of the United States* or the *Constitution of the State of Nevada*. The committee may have jurisdiction over other measures having significant constitutional implications, after those measures have been favorably reported out of the standing committee having jurisdiction over the subject matter of those measures and with the concurrence of the presiding officer.

3. **The Committee on Education** has jurisdiction over measures affecting primarily Title 34 of the NRS.

4. **The Committee on Elections, Procedures, and Ethics** has jurisdiction over measures affecting primarily Titles 17 and 24 of NRS, **except measures affecting state and local revenue, which are to be referred to the Committee on Taxation.**
