## INTRODUCTION, FIRST READING AND REFERENCE

By Assemblyman Claborn:

Assembly Bill No. 111—AN ACT relating to wildlife; providing for the ineligibility of a person to apply for a tag to hunt bighorn sheep or antlered bull elk under certain circumstances; and providing other matters properly relating thereto.

Assemblyman Claborn moved that the bill be referred to the Committee on Natural Resources, Agriculture, and Mining.

By Assemblymen Parnell, Pierce, Parks, McClain, Anderson, Atkinson, Bobzien, Buckley, Gansert, Gerhardt, Kirkpatrick, Koivisto, Leslie, Ocegüera, Ohrenschall, Segerblom, Smith, and Womack:

Assembly Bill No. 112—AN ACT relating to protective orders; expanding the circumstances which prohibit a court from admitting a person who is

arrested for violating an order for protection against domestic violence to bail sooner than 12 hours after his arrest; applying the same standards for not admitting a person to bail sooner than 12 hours after his arrest to a person arrested for violating an order for protection against stalking, aggravated stalking or harassment; establishing the amount of bail that the arrested person must post to be released for such an offense when the amount has not otherwise been established by the court or magistrate; and providing other matters properly relating thereto.

Assemblywoman Parnell moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 113—AN ACT relating to solid waste; requiring the State Environmental Commission to adopt regulations establishing standards for the construction of liner and leachate collection systems for certain municipal solid waste landfills and requiring the installation of a liner and leachate collection system at certain such landfills; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Pierce moved that the bill be referred to the Committee on Health and Human Services.

Assembly Bill No. 114—AN ACT relating to personal identifying information; requiring solicitors to verify addresses on applications for credit when offering credit cards by mail; providing for a civil action for crimes involving the theft of personal identifying information; and providing other matters properly relating thereto.

Assemblywoman Pierce moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 115—AN ACT relating to mines; making various changes governing the regulation of mines with the potential to emit mercury; requiring the State Environmental Commission to raise additional revenue from fees charged for operating permits issued to certain mine operators to pay for certain projects relating to mercury emissions; providing penalties; and providing other matters properly relating thereto.

Assemblywoman Leslie moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblyman Carpenter:

Assembly Bill No. 116—AN ACT relating to crimes; reducing the minimum quantity of a controlled substance or other related substance required to constitute certain crimes of trafficking in those substances; increasing the minimum term and maximum term of imprisonment for the commission of such a crime; establishing a minimum mandatory amount of bail to be set for a person who is arrested for a violation of such a crime in certain circumstances; and providing other matters properly relating thereto.

Assemblyman Carpenter moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblyman Carpenter:

Assembly Bill No. 117—AN ACT relating to divorce; providing that the parents, guardians and siblings of parties to an action for divorce must not be excluded from observing the proceedings; and providing other matters properly relating thereto.

Assemblyman Carpenter moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 118—AN ACT relating to motor vehicles; requiring the designation of specific lanes on certain highways on which certain larger vehicles must travel; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Denis moved that the bill be referred to the Committee on Transportation.

By the Committee on Government Affairs:

Assembly Bill No. 119—AN ACT relating to public employees' retirement; revising provisions governing the purchase by a state agency of credit for service in the Public Employees' Retirement System on behalf of certain employees under certain circumstances; and providing other matters properly relating thereto.

Assemblywoman Kirkpatrick moved that the bill be referred to the Committee on Government Affairs.

By the Committee on Government Affairs:

Assembly Bill No. 120—AN ACT relating to land use planning; revising the notice requirements for proposals to vacate certain rights-of-way or easements; and providing other matters properly relating thereto.

Assemblywoman Kirkpatrick moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By the Committee on Government Affairs:

Assembly Bill No. 121—AN ACT relating to state financial administration; revising provisions relating to the collection of certain debts owed to the State; and providing other matters properly relating thereto.

Assemblywoman Kirkpatrick moved that the bill be referred to the Committee on Government Affairs.

By the Committee on Government Affairs:

Assembly Bill No. 122—AN ACT relating to counties; revising the provisions governing systems used for reporting emergencies in certain counties; and providing other matters properly relating thereto.

Assemblywoman Kirkpatrick moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblywoman Parnell:

Assembly Bill No. 123—AN ACT relating to mental health; requiring public and private mental health facilities to determine whether a person is competent to admit himself voluntarily to such a facility; setting forth the actions a facility must take if a person is determined not to be competent to admit himself voluntarily; providing for the release of certain clinical records; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Parnell moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

Assembly Bill No. 125—AN ACT relating to domestic relations; requiring the court, in certain actions for divorce, to consider any history of domestic violence between the spouses when determining whether to award temporary maintenance or alimony; creating a rebuttable presumption in certain actions for divorce that an award of temporary maintenance or alimony should not be made to a spouse who engaged in certain acts of domestic violence against the other spouse; and providing other matters properly relating thereto.

Assemblyman Manendo moved that the bill be referred to the Committee on Judiciary.
