Assembly Joint Resolution No. 8—Proposing to amend the Nevada Constitution to provide for the biennial transfer under certain circumstances of the surplus in the State General Fund to the Public Employees' Retirement Fund and the Fund for the Public Employees' Benefits Program.

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That a new section, designated Section 6, be added to Article 9 of the Nevada Constitution to read as follows:

**Sec. 6. 1. Except as otherwise provided in subsections 2 and 3, in each odd-numbered year after the close of the fiscal year and before the issuance of the State Controller's annual report, the State Controller shall:**

**(a) Deposit an amount equal to 25 percent of the surplus in the State General Fund to the credit of the Public Employees' Retirement Fund; and**

**(b) Deposit any remaining surplus in the State General Fund to the credit of the Fund for the Public Employees' Benefits Program.**

**2. The State Controller shall only make deposits to the Public Employees' Retirement Fund pursuant to paragraph (a) of subsection 1 to the extent that the Public Employees' Retirement Fund is not at least 85 percent funded.**

3. *The State Controller shall only make deposits to the Fund for the Public Employees' Benefits Program pursuant to paragraph (b) of subsection 1 to the extent that the Fund for the Public Employees' Benefits Program is not at least 85 percent funded.*

4. *For the purposes of this section, a fund shall be deemed to be at least 85 percent funded if the actuarial value of the assets of the fund is equal to or greater than 85 percent of the actuarial accrued liabilities of the fund, as determined in accordance with generally accepted accounting principles for government as prescribed by the Governmental Accounting Standards Board.*

5. *The Nevada Legislature shall prescribe a method for determining the surplus in the State General Fund for the purposes of this section.*
