RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That Section 5 of Article 4 of the Nevada Constitution be amended to read as follows:

Sec. 5. *I.* Senators and members of the Assembly shall be duly qualified electors in the respective counties and districts which they represent, and the number of Senators shall not be less than one-third nor more than one-half of that of the members of the Assembly.

2. It shall be the mandatory duty of the Legislature at its first session after the taking of the decennial census of the United States in the year 1950, and after each subsequent decennial census, **and any other federal census**, to fix by law the number of Senators and Assemblymen ~~and apportion them among the several counties of the State, or among legislative districts which may be established by law, according to the number of inhabitants in them, respectively.~~

3. *Whenever there is reason to reapportion the Legislature into new legislative districts or to provide new congressional district boundaries, or both, because of a new federal census or because of a decision of a court of competent jurisdiction, the Secretary of State shall order the formation of a commission for reapportionment.*

4. *The commission must be composed of six members. The leaders of the two largest political parties of each House of the Legislature shall each designate one member, and the state chairmen of the two largest political parties, determined by the vote cast for Governor in the last gubernatorial election, shall each designate one member. In the event any appointing authority does not select the members within 15 calendar days following the order of the Secretary of State to form the commission, the Supreme Court shall appoint such members. No member of the commission may be an elected or appointed official in the State of Nevada at the time of designation or selection.*

5. *The Legislature shall enact laws providing for the implementation of the provisions of this section, including, without limitation, terms of commission members, the method of filling vacancies on the commission, additional qualifications for commissioners and additional standards to govern the commission. The Legislature shall appropriate funds to enable the commission to carry out its duties.*

6. *Within 90 days after the Legislature has fixed the number of Senators and Assemblymen pursuant to subsection 2, the commission shall file a proposed plan for apportioning the Senate and Assembly of the Legislature with the Office of the Secretary of State. At the same time, and with the same effect, the commission shall prepare and file a plan for congressional districts. Any final action of the commission on a proposed plan must be approved by a vote of two-thirds of the members of the commission. All deliberations of the commission must be open to the public.*

7. *The legislative districts created by the commission are in effect for all elections held after the plan is filed and until a new plan is required and filed unless amended by court order. The Supreme Court shall have original jurisdiction over actions involving challenges to legislative apportionment.*

8. *A member of the commission may not serve in either House of the Legislature for 5 years following the service of such member on the commission.*
