INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 150—AN ACT relating to tanning establishments; providing for the regulation of tanning establishments by the State Board of Cosmetology; prohibiting a person from operating a tanning establishment unless he is licensed by the Board; prescribing the requirements for licensure; providing standards for the operation of tanning establishments and tanning equipment; and providing other matters properly relating thereto.

Assemblywoman Koivisto moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 151—AN ACT relating to mortgage lending; requiring a mortgage broker to include his license number on any loan secured by a lien on real property for which he engages in activity as a mortgage broker;

requiring certain financial institutions that offer nontraditional mortgage loan products to make certain disclosures to borrowers with respect to nontraditional mortgage loans; requiring such financial institutions to certify such disclosures to the Commissioner of Financial Institutions; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Committee on Commerce and Labor.
