INTRODUCTION, FIRST READING AND REFERENCE

Senate Bill No. 117—AN ACT relating to hazardous materials; repealing the provisions creating the Commission on Nuclear Projects and the Agency for Nuclear Projects; transferring certain duties relating to the disposal of

radioactive waste in Nevada to the Governor; and providing other matters properly relating thereto.

Senator Cegavske moved that the bill be referred to the Committee on Energy, Infrastructure and Transportation.

By the Committee on Commerce and Labor:

Senate Bill No. 118—AN ACT relating to warrantors of vehicle protection products; requiring the registration and regulation of warrantors and related sellers and warranty administrators; and providing other matters properly relating thereto.

Senator Carlton moved that the bill be referred to the Committee on Commerce and Labor.

By Senator Carlton (by request):

Senate Bill No. 119—AN ACT relating to professions; revising provisions governing the regulation of massage therapists by the Board of Massage Therapists; prohibiting certain misleading and deceptive practices relating to massage therapy; revising provisions governing the discipline of massage therapists; authorizing the Board to issue administrative citations and to impose administrative fines for certain violations; revising provisions governing the temporary suspension of licenses of massage therapists; requiring law enforcement agencies to provide certain records to the Board or its Executive Director upon request; providing remedies and penalties; and providing other matters properly relating thereto.

Senator Carlton moved that the bill be referred to the Committee on Commerce and Labor.

If you talk to some of the old-time residents of Moapa Valley and Logandale, they will tell you that chapel was built at a time when members of the church were real participants in its building. Some of the older residents of that community will tell you about going to church on a Saturday morning to help make the bricks that built that building. I want to stand, today, and recognize that tragedy and to honor that building for the history it represents for that community. I want to ask you to remember the residents in that community in your thoughts and prayers.
