Assembly Concurrent Resolution No. 4—Expressing support for economic development and the development of a highly skilled workforce in the sectors of logistics, supply chain management and renewable energy technology in this State.

INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Commerce and Labor:

Assembly Bill No. 131—AN ACT relating to occupational diseases; revising provisions relating to minimum duration of incapacity; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Committee on Commerce and Labor.

By the Committee on Legislative Operations and Elections:

Assembly Bill No. 132—AN ACT relating to elections; revising provisions governing the dates for certain city elections; revising deadlines for the submission of certain campaign contribution and expenditure reports relating to city elections; and providing other matters properly relating thereto.

Assembly Bill No. 133—AN ACT relating to energy; revising provisions governing the Solar Energy Systems Incentive Program to require the Public Utilities Commission of Nevada to establish by regulation program terms which periodically reduce the cumulative capacity of solar energy systems that is allocated for participation in the Solar Program; requiring the Commission to establish by regulation the categories of property that are eligible for participation in the Solar Program and the amount of capacity that is allocated for participation in the Solar Program for each category; requiring that the amount of any incentives available pursuant to the Solar Program be based in part on the amount of electricity produced by a solar energy system; increasing the cumulative capacity of net metering systems which may operate within the service area of an electric utility; requiring the Commission to conduct certain investigations related to the allocation of capacity for net metering systems; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Committee on Commerce and Labor.

By the Committee on Judiciary:

Assembly Bill No. 134—AN ACT relating to criminal procedure; prohibiting the imposition of a sentence of life imprisonment without the possibility of parole upon a juvenile offender convicted of a non-homicide crime; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Committee on Judiciary.

By the Committee on Judiciary:

Assembly Bill No. 135—AN ACT relating to probation; prohibiting a court from ordering a term of imprisonment for certain violations of probation; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Committee on Judiciary.

By the Committee on Judiciary:

Assembly Bill No. 136—AN ACT relating to offenders; revising provisions governing credits for offenders sentenced for certain crimes; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Committee on Judiciary.

By the Committee on Education:

Assembly Bill No. 137—AN ACT relating to education; requiring the implementation of a school breakfast program at each public school designated as demonstrating need for improvement for 3 consecutive years or more; requiring school districts and certain public schools to report on school nutrition programs; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Concurrent Committees on Education and Ways and Means.

By the Committee on Education:

Assembly Bill No. 138—AN ACT relating to education; requiring the Department of Education to work in consultation with the Nevada System of Higher Education to establish a plan to ensure that high school pupils are adequately prepared for postsecondary education and success in the workplace; revising certain requirements for the reports of accountability information prepared by the State Board of Education and the boards of trustees of school districts; revising provisions governing the academic plans for ninth grade pupils; requiring school districts to adopt a policy for

remediation of deficient credits; requiring school districts to adopt a policy for pupils to report unlawful activities; repealing certain provisions relating to the exemption of certain children from compulsory school attendance; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Committee on Education.

Motion carried.

By Assemblymen Goicoechea, Ellison, and Hansen (by request):

Assembly Bill No. 139—AN ACT relating to emergency medical services; authorizing the use in certain counties of unlicensed persons for the provision of emergency medical care under certain circumstances; revising provisions governing the operation of an ambulance or a vehicle of a fire-fighting agency which provides emergency medical care in certain counties; and providing other matters properly relating thereto.

Assemblyman Conklin moved that the bill be referred to the Committee on Health and Human Services.
