**INTRODUCTION, FIRST READING AND REFERENCE**

Assembly Bill No. 145—AN ACT relating to unincorporated towns; requiring a copy of an ordinance proposing the annexation of an area by an unincorporated town to be sent to each owner of real property in the area

under certain circumstances; and providing other matters properly relating thereto.

Assemblyman Goicoechea moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By the Committee on Health and Human Services:

Assembly Bill No. 146—AN ACT relating to the Office for Consumer Health Assistance; expanding the definition of “consumer” to include more situations in which the Office may render assistance; expanding the authority of the Director of the Office to adopt regulations; authorizing the Director to appoint a designee to mediate, arbitrate or resolve by alternative means certain disputes between patients and hospitals; and providing other matters properly relating thereto.

Assemblywoman Mastroluca moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 147—AN ACT relating to domestic relations; providing that the termination of parental rights does not terminate the right of a child to inherit from his or her parent or parents; and providing other matters properly relating thereto.
