Assembly Bill No. 191—AN ACT relating to taxation; revising provisions governing the partial abatement of certain taxes; and providing other matters properly relating thereto.

Assembly Bill No. 193—AN ACT relating to public works; requiring the State Public Works Board to obtain prior approval from the Nevada Legislature or Interim Finance Committee before cancelling or, in certain circumstances, delaying a project authorized by the Legislature; requiring the Interim Finance Committee to consider certain criteria in determining whether to approve a change in the scope of the design or construction or the cancellation or delay of a project; and providing other matters properly relating thereto.

Assembly Bill No. 194—AN ACT relating to courts; clarifying that a person with a communications disability who participates in a civil judicial proceeding must not be required to pay for interpretive services; and providing other matters properly relating thereto.
