INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Aizley, Carrillo, Ohrenschall, Pierce, and Segerblom; Senators Parks and Leslie:

Assembly Bill No. 234—AN ACT relating to public accommodations; authorizing health authorities to establish a plan for integrated pest management practices in places of public accommodation; prohibiting the use of volatile organic compounds and certain other substances by places of public accommodation under certain circumstances; prohibiting the use of a pesticide by a place of public accommodation in any manner inconsistent with a plan for integrated pest management practices in places of public accommodation; providing penalties; and providing other matters properly relating thereto.

Assemblyman Aizley moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblymen Aizley, Carrillo, Flores, Hogan, Ohrenschall, Pierce, and Segerblom:

Assembly Bill No. 235—AN ACT relating to marijuana; exempting from state prosecution certain persons who engage in the medical use of marijuana; authorizing the production of marijuana under certain circumstances; authorizing the compensation of certain persons who provide marijuana for medical use under certain circumstances; authorizing a local government to adopt ordinances relating to the medical use of marijuana; increasing the amount of marijuana that a person may legally possess for medical use under certain circumstances; providing that the obtaining of a registry identification card for the medical use of marijuana is voluntary; prohibiting a person from engaging in the medical use of marijuana within a certain distance of certain places; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Aizley moved that the bill be referred to the Committee on Health and Human Services.
