Assembly Bill No. 243—AN ACT relating to state financial administration; creating the position of State Grants Coordinator within the Budget Division of the Department of Administration; creating the State Grants Master Service Agreement Fund; increasing the amount of certain gifts and grants that a state agency may accept under certain circumstances; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 247—AN ACT relating to vehicles; requiring the Department of Motor Vehicles to issue a decal exempting a person from obtaining a license to operate a road machine, farm tractor or implement of husbandry on a highway under certain circumstances; requiring the decal to be displayed on the road machine, farm tractor or implement of husbandry in the manner specified by the Department; authorizing the Department to issue a new decal upon the payment of a fee if a decal is lost or destroyed; revising the circumstances under which a person is exempt from obtaining a license to drive a road machine, farm tractor or implement of husbandry on a highway; and providing other matters properly relating thereto.

Assemblyman Goicoechea moved that the bill be referred to the Committee on Transportation.
