INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Bustamante Adams, Horne, and Conklin:

Assembly Bill No. 271—AN ACT relating to real property; providing for the regulation of private transfer fee obligations affecting real property; providing that certain such obligations are void and unenforceable; revising the disclosures that a seller of real property must make to a buyer to include certain information concerning such obligations; and providing other matters properly relating thereto.

Assemblywoman Bustamante Adams moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 272—AN ACT relating to juveniles; excluding certain crimes from the jurisdiction of the juvenile court; revising the provisions governing the certification of certain juveniles as adults for criminal proceedings; providing for the detention of a child during certain proceedings; and providing other matters properly relating thereto.

Assemblywoman Flores moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 273—AN ACT relating to real property; revising provisions governing the amount which a person holding a junior lien on real property may recover in a civil action under certain circumstances; prohibiting certain persons holding a junior lien on certain residential property from bringing a civil action under certain circumstances; revising provisions governing the amount of a deficiency judgment after the foreclosure of a mortgage or a deed of trust; and providing other matters properly relating thereto.

Assemblyman Atkinson moved that the bill be referred to the Committee on Commerce and Labor.

By the Committee on Commerce and Labor:

Assembly Bill No. 274—AN ACT relating to insurance; establishing provisions regarding the payment of proceeds of any benefit under a policy of life insurance or a policy of group life insurance; requiring certain disclosures by an insurer before offering to pay the proceeds of a policy of life insurance or a policy of group life insurance in the form of a retained asset account; requiring that any balance remaining in a retained asset account be returned to the beneficiary if the beneficiary does not use the account in a 3-year period; and providing other matters properly relating thereto.

Assemblyman Atkinson moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 275—AN ACT relating to highways; requiring private contractors, under certain circumstances, to remove from freeways and highways devices for the temporary diversion of traffic; providing a penalty; and providing other matters properly relating thereto.

Assembly Bill No. 282—AN ACT relating to firearms; authorizing certain members or veterans of the Armed Forces of the United States, a reserve component thereof or the National Guard, who are at least 18 but less than 21 years of age, to obtain a permit to carry a concealed firearm; revising provisions concerning permits to carry concealed semiautomatic firearms; revising provisions governing the renewal of a permit to carry a concealed firearm; revising provisions concerning the confidentiality of information relating to permits to carry concealed firearms; revising provisions governing the possession and discharge of firearms in state parks; and providing other matters properly relating thereto.
