WHEREAS, The members of the Nevada Legislature note with sorrow the passing of Enos LeRoy Arrascada, a third generation Basque Nevadan, on December 15, 2009; and

WHEREAS, Born in Elko on August 19, 1936, to Ignacio “Enos” Arrascada and Maxine Cook, LeRoy graduated from Elko High School, was always involved in campus life and student government; and

WHEREAS, He attended the University of Nevada, Reno, where he successfully ran for the Student Senate, defeating classmate Richard Bryan, who went on to serve as Nevada Governor and United States Senator; and

WHEREAS, After graduating from college in 1959, LeRoy enlisted in the United States Navy and, upon discharge, entered the American University Washington College of Law in Washington, D.C., to pursue his lifelong love of the law; and

WHEREAS, While attending law school, LeRoy worked in a patronage position operating an elevator in the United States Capitol, and as fate would have it, it was in that elevator that he met the love of his life and best friend, Ellen Sullivan Arrascada, a congressional secretary, whereupon they married and moved to Reno in 1964; and

WHEREAS, Leroy loved this State with its deserts and mountains, and one of his great joys in life was going hunting and fishing in northern Nevada; and

WHEREAS, Never one to retire from his passion for the law, LeRoy worked until the day before he passed, was considered one of the true gentlemen of the legal profession and was a law partner with his son John and daughter Christine, fulfilling a dream that few fathers attain; and

WHEREAS, Very civic-minded, Leroy was extremely active in the community and was a founder and first President of the Reno Zazpiak Bat Basque Club, a former President of the Washoe County Bar Association, the Reno Host Lions Club and the Reno Aquatic Club, a former Chairman of the Democratic Party of Washoe County, a founding member of the Nevada Trial Lawyers Association and a member of the Humboldt Hunting Club, the Prospectors’ Club, the Nevada Woodchucks and the Gold and Silver coffee group, and his dedication to his many causes will be sorely missed by all; now, therefore, be it

## IN COMMITTEE OF THE WHOLE

Staff presentation on Assembly redistricting proposals considered.

## CHAIR OCEGUERA:

The Committee of the Whole will come to order. The Committee of the Whole will form for the purposes of presenting redistricting proposals before the entire body. There will not be debate on the same day the proposal is issued or introduced, rather the purpose of this Committee, which we anticipate being brief, is to ensure that all members are informed of these plans. Today our nonpartisan staff will be presenting the core facts about each proposal. The proposals will be formally introduced and referred to the Legislative Operations and Elections Committees next week. As our staff is nonpartisan, they will not be taking questions on the maps unless necessary to clarify a remark. They do not know the why's and how's of how it was done, they just know the facts. At the same time, we will move to make sure all maps are available to the public and the membership with the opportunity to give comment through the end of the week and through next week when the proposals are heard in committee. Members will subsequently be able to give comment when the committee forwards the proposal to the floor. All proposals will be loaded on the public work stations in Carson City and Las Vegas as well as displayed in the map room for the Assembly that will be the Committee on Natural Resources room. The proposals are now on the Nevada Electronic Legislative Information Service (NELIS). If you look on NELIS you should be able to pull up the proposals on NELIS as well. They will be on the legislative website homepage under "Redistricting and Reapportionment." If there are no questions or comments from members at this time, I will ask that they be referred to the Legislative and Operations Committee for discussion at that level. At this time I would like to ask Kathy Steinle and Michael Stewart to walk us through the main information regarding each of these proposals. Again, staff is nonpartisan, so they will be taking only the technical questions that you may have. I would also like to recognize the number of members from the Senate that are in the gallery and say "hello."

## MICHAEL STEWART, SUPERVISING PRINCIPAL RESEARCH ANALYST, LEGISLATIVE COUNSEL BUREAU:

Good afternoon, Mr. Chairman and members of the Committee of the Whole. For the record, I am Michael Stewart, with the Research Division of the Legislative Counsel Bureau. Joining me today is Kathy Steinle, Geographic Information Systems Manager with the LCB Technology Services Unit. As Speaker Ocegueda mentioned, we have been asked today to provide factual information regarding various reapportionment and redistricting plans that have been compiled

by both majority political parties of the Nevada State Legislature. Before we begin I must remind you it is our standard LCB disclosure that as central and nonpartisan staff, we cannot advocate for the passage or defeat of any legislation or in this case any redistricting plan. We are here today to present only basic factual information about two redistricting plans impacting the Nevada State Assembly and one redistricting plan prepared by the Republican Party regarding Nevada's Congressional Districts. With each plan, Kathy will start with an explanation of the key geographic components and features of the overall plan and some district specific information, and I will follow that with a brief summary of some statistical information specifically population, deviation from ideal population, and information regarding race and ethnic minority concentrations in some of our legislative districts. So with that, I will turn it over to Kathy who will begin with the redistricting plan prepared by Assembly Democrats.

KATHY STEINLE, GEOGRAPHIC INFORMATION SYSTEMS (GIS) MANAGER, LEGISLATIVE COUNSEL BUREAU:

Thank you. We are just going to go through a series of maps. We will look at a statewide view. We will look at a western Nevada view and a Clark County Las Vegas area view. I'm just going to briefly describe the districts and what they look like. You may get a closer view on NELIS, if that helps. This is the statewide view of the Assembly Democrat's plan. You can see that the rural District 33 has Elko, Eureka, part of Lincoln and White Pine Counties. District 35 has part of Churchill, part of Lyon, and part of Storey Counties. District 36 has parts of Clark, Lincoln, and Nye Counties. District 38 has part of Churchill, part of Douglas, Esmeralda, Humboldt, Lander, part of Lyon, Mineral, and parts of Nye and Pershing Counties. The next map you see here is of the western Nevada area and the inset map gives you a reference of the area you are looking at, mostly the Reno-Sparks area. In this area, you see Districts 24, 25, 27, and 30, 31, and 32 are wholly contained within Washoe County. The final map for this Assembly plan, shows the Las Vegas area. Districts 1 through 23 are wholly contained within Clark County. Districts 28, 29, 34, 37, 39, 41, and 42 are also wholly contained within Clark County. There are a few districts that dip down in from some of the northern counties. District 36 is one of those that I mentioned earlier. That's the only one that dips down. After the conclusion of the maps, Michael will go through some of the population figures which are also on NELIS in tables.

MICHAEL STEWART:

Thank you. The next thing on your NELIS, and I believe you also have hard copies for better view, is the population report for this particular plan. As you know, when we redistrict the goal is to try and achieve as equal a population as possible. The ideal population for this round of redistricting for the Assembly is 64,299. On this particular plan the largest positive deviation is 0.75 percent for District 33, and 0.88 is the largest negative deviation in District 35, so the overall range of deviation, positive and negative, is 1.62 percent.

The next important factor, I think, is on this next chart as it relates to ethnic and racial data. Looking first at the far right-hand column is the Hispanic-Latino. I would note that the district with the highest rate of Hispanic-Latino is District 28, at 73.17 percent, followed by District 11 at 71.22 percent, and District 19 at 53.28 percent. Now, as you can see, there are also four other districts with a Hispanic population of over 40 percent; that would be Districts 6, 12, 14, and 15. You will also see on that same chart with regard to Black African-American populations, there are several districts, actually three districts, with over 20 percent. In fact, one is over 30 percent, and that is District 7, at 31.02 percent Black African-American. In District 6, the Black African-American population in this plan is 26.13 percent; in District 17, 22.30 percent. I would note also with the Asian population, if you look in the center of this table, there is one district, number 39, with 26.63 percent Asian, and District 8 at 20.75 percent. So, those are kind of the key population statistics that might be of interest to you as it relates to the standard deviations and also the ethnic and minority breakdowns.

The third page is—we didn't highlight any specifics here, but this is the voting age population. It's on NELIS. I will turn it over to Kathy, again, to discuss the plan that was graded and submitted by the Senate Republicans.

KATHY STEINLE:

For the record, Kathy Steinle. We are going to look at the same three basic views for the Assembly Republican Plan. We are going to look at a statewide western area and the Las Vegas, Clark County area. So, looking at the map, you can see District 16 has Elko, parts of Eureka, Lander, Lincoln, and Nye Counties, and all of White Pine County. District 17 has parts of Carson City, Churchill, Lyon, Storey, and Washoe Counties. District 18, on the top left, has all of Humboldt, part of Lander, all of Pershing, and part of Washoe Counties. District 22, more in the center of the map, has part of Churchill, all of Douglas, Esmeralda, parts of Eureka, Lander, Lyon, Nye Counties, and all of Mineral County. District 23 picks up a few other counties and has parts of Carson City, Lyon, Storey, and Washoe Counties. Down at the bottom in the rural area still, District 24 has parts of Clark, Lincoln, and Nye Counties. Now, looking in the Washoe County Reno–Sparks area, you can see District 6 is wholly contained in Washoe County, along with Districts 15, 19, 20, and 21. Then, Districts 14 and 18 dip into Washoe County as well, along with District 23. Looking at the Las Vegas area view in Clark County, we have Districts 1 through 5, Districts 7 through 13 and 15, and Districts 25 through 42 are all contained within Clark County. District 24 has part of Clark County. The rest are wholly contained.

MICHAEL STEWART:

Turning to the statistical information on this particular plan, you can see it there on NELIS, all on one page. I would note that the District numbers on this particular page do not necessarily correlate with the current districts and members, so I wanted to clarify that. Again, for the ideal population, we are looking at 64,299 with the largest positive deviation in District 40 of plus 0.47 percent and also the same negative deviation of minus 0.47 percent in District 18. Looking at some data relating to race and ethnicity the Hispanic–Latino population, District 4 is shown as the highest Hispanic population at 59.2 percent, and District 3 at 58.3 percent, and District 9 at 58.1 percent. There are over eight Hispanic districts over 50 percent. So, we also have this in District 2, 5, Washoe District 6, 7, and 8. This particular chart also shows Hispanic voting–age population. Of those on this chart, seven of these districts are over 50 percent in the Hispanic voting–age population as well. The data also includes Black African American voting-age population. The notable district here is the first one on the page, District 1 at 37.8 percent. I think that covers that particular one. Next, Kathy will review the Republican Congressional Plan.

KATHY STEINLE:

Again, we're going to do the same three views. We have the statewide, western, and Clark. This one because there are only four districts, it's a little easier to see where those are going. District 1 and 4 are the ones in Clark County. District 2 has all of Carson City, Churchill, Elko, Eureka, Humboldt, Lander, Pershing, Storey, Washoe, White Pine Counties, and parts of Douglas and Lyon Counties. The northern district you see on the map. District 3, the one just below District 2, has parts of Clark, Douglas, Lyon Counties, all of Esmeralda, Lincoln, Mineral and Nye Counties. Here is the Las Vegas Clark County view, and you can see District 1 and 4 are wholly contained within Clark County. District 3, the part that dips down into Clark County, surrounds those two districts. Here is a closer view of the two northern Districts 2 and 3. Michael will cover some of the numbers.

MICHAEL STEWART:

In the final slide is the data set for the Republican Congressional Plan. I would point out that for the redistricting for the congressional districts this session is 675,138 for the ideal population. You can see that the largest positive deviation is zero, and the largest negative

deviation is one, so it's basically one. The total Hispanic—there is one in congressional District 4; one Hispanic majority district at 50.7 percent. That same District also has Black African American voting age population of 14.2 percent. You can see the other data there as it relates to the other districts. I think with that we have covered everything and will turn it back to the chair.

CHAIR OCEGUERA:

Certainly, any clarifying questions for the nonpartisan staff. I have one question, really quickly, I noticed on the Democratic maps you have streets and one the Republican maps you don't. So, if I go to the public works station I'll be able to see streets or not?

KATHY STEINLE:

Mr. Speaker, we have not been given the Republican electronic maps, yet. However, they will all be made available on the website through NELIS and the redistricting webpage.

CHAIR OCEGUERA:

Mr. Goicoechea, when do you think we will have that data where you could look specifically?

ASSEMBLYMAN GOICOECHEA:

You're asking the wrong person. I'm sorry, I know it has to be available; we are looking forward to seeing the streets laid into this also.

CHAIR OCEGUERA:

Should I ask the Senate? They're all upstairs. Sorry, I couldn't resist. Are there other questions from the Committee?

KATHY STEINLE:

I also wanted to make sure that everyone knew, speaking of the public work sessions, that they're available and wanted to plug our website one more time and say that it will have all these maps available to anybody who wants any further detail. Also, immediately following the Senate Committee of the Whole, we will be going upstairs and posting all three of the maps you've seen plus the two Senate maps we'll be presenting over in the Senate. So, you'll be able to see the maps and all the tables in very large format so you get a lot more detail. Thank you.

CHAIR OCEGUERA:

Thank you, Ms. Steinle. Questions from the Committee? Alright, seeing none, Mr. Conklin.
