ASSEMBLYWOMAN DIAZ:

I rise in support of Senate Concurrent Resolution 12. It is a great honor for me to be here with the Escobedo family. I knew Eddie, as we all lovingly knew him, about 14 years of my short existence, but he did many, many things during his time here on earth. He truly did live the American dream. As you heard, he was in the armed forces then opened his own newspaper, and was involved with the radio. He used that all for good cause to make sure he advocated for the community, especially the Hispanic community, making sure that we had our place and our role.

Eddie was especially engaged in making sure that the Hispanics were engaged in politics. That is where I was at kind of a crossroads with Mr. Escobedo where he was trying to mobilize the Latino community to turn out and vote for those candidates that represented their views. I will

forever be so thankful for the active role he had while he was here. He was a great asset to the state of Nevada, and I urge everybody to adopt the resolution.

ASSEMBLYMAN BROOKS:

I rise in support. I just want to say that Eddie Escobedo was a great man, and I wanted to let his family know and assure them that he helped many of us who are here today to get where we are. He was motivational, inspirational; he stood for what he said and meant what he said. He broke down major barriers for our community. So I thank you, and I thank you for being here with us today.

ASSEMBLYWOMAN FLORES:

I also rise in support of Senate Concurrent Resolution 12, and I also echo the sentiments that my colleagues have already stated. I just also want to add that Mr. Escobedo was not just an upstanding person for the entire community, but he was so special to the Latino community because, as was already said, he fought tirelessly and was an amazing advocate for the Latino community. When I heard of his passing, the first thing that came to mind was, "Wow, he was not able to make it to the day to see so many Hispanics elected for the first time to the Nevada Legislature." He fought for so many years to increase the representation for this community, and he passed, unfortunately, just before he was able to realize that.

So I also just want to put on the record that he is such an amazing loss to the community but his legacy is enduring. Much of the progress that you see that our community, the Latino community, has made really is a direct result of this man. Thank you very much, and I also urge support of my colleagues for Senate Concurrent Resolution No. 12.

ASSEMBLYWOMAN BUSTAMANTE ADAMS:

Thank you, Mr. Speaker. It is an honor to be able to have the Escobedo family here today with us. I just want to let the Escobedo family know that Eddie played a very instrumental role in my life, especially when I broadened my horizons on the national level. Eddie was the one who introduced me to the National Association of Hispanic Publications; he took me under his wing, and I was able to develop great relationships because of Mr. Escobedo. I agree with my colleagues from the south that when it was time for him to head home, it was a great loss for our community because he didn't get to see the fruit of his labor—we being here on the Floor and over in the Senate. But I want you to rest assured that we are the product of his efforts to invest in the young people, especially in the Latino community. I also want to express my gratitude for you and for being here today.

I rise in support of Senate Concurrent Resolution 12. Today, or recently, here is how he was described: "Eddie Escobedo lived the American Dream. He never let go of his belief that through hard work and creativity, a person could succeed and help his family and friends." That was from Brian Greenspun who was a publisher of the *Las Vegas Sun*. As somebody who worked in the publishing industry, he was admired, he lived the American Dream, and he will be missed.
