

ASSEMBLY BILL NO. 153—ASSEMBLYMEN HARDY, HAMBRICK;  
ELLISON, FIORE, GRADY, LIVERMORE AND WHEELER

FEBRUARY 20, 2013

Referred to Committee on Commerce and Labor

SUMMARY—Provides for the licensing and operation of craft distilleries in Nevada. (BDR 52-607)

AN ACT relating to alcoholic beverages; providing for the licensing and operation of craft distilleries in this State; setting forth the conditions under which spirits manufactured at such craft distilleries may be sold; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law provides for the operation of brew pubs and instructional wine-  
2 making facilities. (NRS 597.230, 597.245) Under existing law, facilities such as  
3 brew pubs and instructional wine-making facilities must be licensed, a fee is  
4 imposed for the license, and a person who engages in business in this State without  
5 having the appropriate permit or license for the business is guilty of a  
6 misdemeanor. (NRS 360.490, 369.180, 369.300)

7 This bill: (1) authorizes the operation of craft distilleries in Nevada; (2) sets  
8 forth the permissible scope of operation for those craft distilleries; (3) requires that  
9 the craft distilleries be licensed; and (4) imposes a licensing fee of \$75.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 597 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3 ***1. A person may operate a craft distillery if the person:***  
4 ***(a) Obtains a license for the facility pursuant to chapter 369 of***  
5 ***NRS;***



1 (b) *Complies with the requirements of this section; and*  
2 (c) *Complies with any other applicable governmental*  
3 *requirements.*

4 2. *A person who operates a craft distillery pursuant to this*  
5 *section may:*

6 (a) *In addition to manufacturing spirits from agricultural raw*  
7 *materials through distillation, blend, age, store and bottle the*  
8 *spirits so manufactured. The person operating the craft distillery*  
9 *shall ensure that none of the spirits manufactured at the craft*  
10 *distillery are derived from neutral or distilled spirits manufactured*  
11 *by another manufacturer.*

12 (b) *In any calendar year, sell and transport in Nevada not*  
13 *more than 15,000 cases of spirits manufactured at the craft*  
14 *distillery to a person who holds a valid license to engage in*  
15 *business as a wholesale dealer of liquor pursuant to chapter 369*  
16 *of NRS.*

17 (c) *Export in any quantity to another state the spirits*  
18 *manufactured at the craft distillery.*

19 (d) *On the premises of the craft distillery, serve samples of the*  
20 *spirits manufactured at the craft distillery. Any such samples must*  
21 *not exceed, per person, per day, 1 fluid ounce in volume of each*  
22 *type of spirit manufactured at the craft distillery.*

23 (e) *On the premises of the craft distillery:*

24 (1) *Serve the spirits manufactured at the craft distillery by*  
25 *the glass for consumption on the premises; and*

26 (2) *Sell the spirits manufactured at the craft distillery at*  
27 *retail for consumption on or off the premises. Any such spirits sold*  
28 *at retail for off-premises consumption must not exceed, per*  
29 *person, per day, one-half gallon in volume of each type of spirit*  
30 *manufactured at the craft distillery. Spirits purchased on the*  
31 *premises of a craft distillery may not be resold by the purchaser or*  
32 *any retail liquor store.*

33 3. *As used in this section, "case of spirits" means 12 bottles,*  
34 *each containing 750 milliliters of distilled spirits.*

35 **Sec. 2.** NRS 597.200 is hereby amended to read as follows:

36 597.200 As used in NRS 597.190 to 597.250, inclusive, *and*  
37 *section 1 of this act*, unless the context otherwise requires:

38 1. "Alcoholic beverage" means any malt beverage or  
39 spirituous, vinous or malt liquor which contains 1 percent or more  
40 ethyl alcohol by volume.

41 2. "Brew pub" means an establishment which manufactures  
42 malt beverages and sells those malt beverages at retail pursuant to  
43 the provisions of NRS 597.230.

44 3. *"Craft distillery" means an establishment which:*



1 (a) *Manufactures distilled spirits from agricultural raw*  
2 *materials through distillation; and*

3 (b) *Is authorized to sell and distribute those distilled spirits*  
4 *pursuant to the provisions of section 1 of this act.*

5 4. *“Distillation” means the process of producing or purifying*  
6 *spirituous liquor by successive evaporation and condensation.*

7 5. “Engage in” includes participation in a business as an owner  
8 or partner, or through a subsidiary, affiliate, ownership equity or in  
9 any other manner.

10 ~~14~~ 6. “Instructional wine-making facility” means an  
11 instructional wine-making facility operated pursuant to  
12 NRS 597.245.

13 ~~15~~ 7. “Legal age” means the age at which a person is legally  
14 permitted to purchase an alcoholic beverage pursuant to  
15 NRS 202.020.

16 ~~16~~ 8. “Malt beverage” means beer, ale, porter, stout and other  
17 similar fermented beverages of any name or description, brewed or  
18 produced from malt, wholly or in part.

19 ~~17~~ 9. “Supplier” has the meaning ascribed to it in  
20 NRS 597.140.

21 ~~18~~ 10. “Wine” has the meaning ascribed to it in  
22 NRS 369.140.

23 **Sec. 3.** NRS 597.210 is hereby amended to read as follows:

24 597.210 1. Except as otherwise provided in NRS 597.240,  
25 *and section 1 of this act*, a person engaged in business as a supplier  
26 or engaged in the business of manufacturing, blending or bottling  
27 alcoholic beverages within or without this State shall not engage in  
28 the business of importing, wholesaling or retailing alcoholic  
29 beverages.

30 2. This section does not:

31 (a) Preclude any person engaged in the business of importing,  
32 wholesaling or retailing alcoholic beverages from owning less than  
33 2 percent of the outstanding ownership equity in any organization  
34 which manufactures, blends or bottles alcoholic beverages.

35 (b) Prohibit a person engaged in the business of rectifying or  
36 bottling alcoholic beverages from importing neutral or distilled  
37 spirits in bulk only for the express purpose of rectification pursuant  
38 to NRS 369.415.

39 (c) Prohibit a person from operating a brew pub pursuant to  
40 NRS 597.230.

41 (d) Prohibit a person from operating an instructional wine-  
42 making facility pursuant to NRS 597.245.

43 (e) *Prohibit a person from operating a craft distillery pursuant*  
44 *to section 1 of this act.*



1       **Sec. 4.** NRS 597.220 is hereby amended to read as follows:  
2       597.220 1. ~~[Any]~~ *Except as otherwise provided in section 1*  
3 *of this act, a* person who is engaged in the business of importing or  
4 wholesaling alcoholic beverages in the State of Nevada shall not  
5 engage in the business of retailing alcoholic beverages in this state.

6       2. For the purposes of this section, a person who transfers or  
7 receives alcoholic beverages in the manner described in NRS  
8 369.4865 must not be considered to be engaged in the business of  
9 wholesaling alcoholic beverages based solely upon those transfers.

10       **Sec. 5.** NRS 597.250 is hereby amended to read as follows:  
11       597.250 The license of any person who violates the provisions  
12 of NRS 597.210, 597.220, 597.230 or 597.245 *or section 1 of this*  
13 *act* must be suspended or revoked in the manner provided in chapter  
14 369 of NRS.

15       **Sec. 6.** NRS 369.180 is hereby amended to read as follows:  
16       369.180 1. In addition to the limitations imposed by NRS  
17 597.210 and 597.220, a person shall not:

18       (a) Import liquors into this State unless the person first secures  
19 an importer's license or permit from this State.

20       (b) Engage in business as a wholesale dealer of wines and  
21 liquors in this State unless the person first secures a wholesale wine  
22 and liquor dealer's license from this State.

23       (c) Engage in business as a wholesale dealer of beer in this State  
24 unless the person first secures a wholesale beer dealer's license from  
25 this State.

26       (d) Operate a winery in this State or export wine from this State  
27 unless the person first secures a wine-maker's license from this  
28 State.

29       (e) Operate an instructional wine-making facility in this State  
30 unless the person first secures a license for the instructional wine-  
31 making facility from this State.

32       (f) Operate a brewery in this State unless the person first secures  
33 a brewer's license from this State.

34       (g) Operate a brew pub in this State unless the person first  
35 secures a brew pub's license from this State.

36       *(h) Operate a craft distillery in this State unless the person*  
37 *first secures a craft distiller's license from this State.*

38       2. A person who holds a license for an instructional wine-  
39 making facility:

40       (a) May engage in any activity authorized by NRS 597.245.

41       (b) May not engage in any other activity for which a license is  
42 required pursuant to this chapter, unless the person holds the  
43 appropriate license for that activity.

44       3. *A person who holds a license for a craft distillery:*



1 (a) *May engage in any activity authorized by section 1 of this*  
2 *act.*

3 (b) *May not engage in any other activity for which a license is*  
4 *required pursuant to this chapter, unless the person holds the*  
5 *appropriate license for that activity.*

6 4. As used in this section:

7 (a) "Brew pub" has the meaning ascribed to it in NRS 597.200.

8 (b) "Brewery" means an establishment which manufactures malt  
9 beverages but does not sell those malt beverages at retail.

10 (c) *"Craft distillery" has the meaning ascribed to it in*  
11 *NRS 597.200.*

12 (d) "Malt beverage" has the meaning ascribed to it in  
13 NRS 597.200.

14 **Sec. 7.** NRS 369.300 is hereby amended to read as follows:

15 369.300 The following is a schedule of fees to be charged for  
16 licenses:

27 **Sec. 8.** NRS 369.382 is hereby amended to read as follows:

28 369.382 Except as otherwise provided in NRS 369.386 and  
29 369.415, *and section 1 of this act*, a supplier shall not engage in the  
30 business of importing, wholesaling or retailing alcoholic beverages  
31 in this State.

32 **Sec. 9.** This act becomes effective on passage and approval.
