SUMMARY—Provides for the issuance of driving privilege cards. (BDR 43-596)

AN ACT relating to motor vehicles; providing for the issuance of a driving privilege card; establishing the contents of an application for a driving privilege card and certain instruction permits; establishing the information that must be contained on a driving privilege card and similarly obtained instruction permits; providing for the expiration and renewal of a driving privilege card; providing that certain provisions of state law which apply to drivers' licenses also apply to a driving privilege card and similarly obtained instruction permits; providing penalties; and providing other matters properly relating thereto.



Legislative Counsel's Digest:

1 Under existing law, the Department of Motor Vehicles issues multiple licenses
2 that confer to a person the privilege of operating a vehicle, including a driver's
3 license, instruction permit, commercial driver's license and certain limited or
4 restricted driver's licenses or instruction permits. (NRS 483.2521, 483.267,
5 483.270, 483.280, 483.340, 483.360, 483.908) The federal Real ID Act of 2005
6 requires any driver's license or identification card issued by a state to meet certain
7 standards to be used for federal identification or other official purposes and allows
8 for a state to issue driver's licenses or identification cards that do not meet such
9 standards if such licenses or cards are of a unique design and clearly state that they
10 may not be used for federal identification or other official purposes. (Real ID Act of
11 2005 § 202, Pub. Law No. 109-13, 119 Stat. 302, 312-15, 49 U.S.C. 30301 note)

12 **Section 5** of this bill sets forth requirements for applications for driving
13 privilege cards and alternative requirements for applications for instruction permits.
14 **Section 5** establishes the information that must be included in such applications,
15 including, without limitation, documents that must be submitted to prove the
16 applicant's name, age, residence in this State and social security number or
17 individual taxpayer identification number. **Section 5** allows an applicant to present
18 various documents, including, without limitation, a birth certificate or passport
19 issued by a foreign government, as proof of his or her name and age. **Section 5**
20 provides that a driving privilege card expires annually on the holder's birthday and
21 may be renewed. **Section 5** requires that a driving privilege card and an instruction
22 permit obtained in accordance with **section 5** contain, in addition to the information
23 contained on a driver's license, a clear statement that it may not be accepted for
24 certain federal purposes and contain a unique design element to alert federal
25 personnel to this information. **Section 5** provides that any provision of title 43 of
26 NRS that applies to a driver's license is deemed also to apply to a driving privilege
27 card and an instruction permit obtained in accordance with **section 5**.

28 **Section 1** of this bill prohibits the Director of the Department from releasing
29 any information from the files and records of the Department relating to legal
30 presence to any person or federal, state or local governmental entity.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 481.063 is hereby amended to read as follows:
2 481.063 1. The Director may charge and collect reasonable
3 fees for official publications of the Department and from persons
4 making use of files and records of the Department or its various
5 divisions for a private purpose. All money so collected must be
6 deposited in the State Treasury for credit to the Motor Vehicle Fund.

7 2. Except as otherwise provided in subsection 6, the Director
8 may release personal information, except a photograph, from a file
9 or record relating to the driver's license, identification card, or title
10 or registration of a vehicle of a person if the requester submits a
11 written release from the person who holds a lien on the vehicle, or
12 an agent of that person, or the person about whom the information is
13 requested which is dated not more than 90 days before the date of
14 the request. The written release must be in a form required by the
15 Director.



1 3. Except as otherwise provided in subsections 2 and 4, the
2 Director shall not release to any person who is not a representative
3 of the Division of Welfare and Supportive Services of the
4 Department of Health and Human Services or an officer, employee
5 or agent of a law enforcement agency, an agent of the public
6 defender's office or an agency of a local government which collects
7 fines imposed for parking violations, who is not conducting an
8 investigation pursuant to NRS 253.0415 or 253.220, who is not
9 authorized to transact insurance pursuant to chapter 680A of NRS or
10 who is not licensed as a private investigator pursuant to chapter 648
11 of NRS and conducting an investigation of an insurance claim:

12 (a) A list which includes license plate numbers combined with
13 any other information in the records or files of the Department;

14 (b) The social security number of any person, if it is requested to
15 facilitate the solicitation of that person to purchase a product or
16 service; or

17 (c) The name, address, telephone number or any other
18 personally identifiable information if the information is requested by
19 the presentation of a license plate number.

20 ➤ When such personally identifiable information is requested of a
21 law enforcement agency by the presentation of a license plate
22 number, the law enforcement agency shall conduct an investigation
23 regarding the person about whom information is being requested or,
24 as soon as practicable, provide the requester with the requested
25 information if the requester officially reports that the motor vehicle
26 bearing that license plate was used in a violation of NRS 205.240,
27 205.345, 205.380 or 205.445.

28 4. If a person is authorized to obtain such information pursuant
29 to a contract entered into with the Department and if such
30 information is requested for the purpose of an advisory notice
31 relating to a motor vehicle or the recall of a motor vehicle or for the
32 purpose of providing information concerning the history of a
33 vehicle, the Director may release:

34 (a) A list which includes license plate numbers combined with
35 any other information in the records or files of the Department; or

36 (b) The name, address, telephone number or any other
37 personally identifiable information if the information is requested by
38 the presentation of a license plate number.

39 5. Except as otherwise provided in subsections 2, 4 and 6 and
40 NRS 483.294, 483.855 and 483.937, the Director shall not release
41 any personal information from a file or record relating to a driver's
42 license, identification card, or title or registration of a vehicle.

43 6. Except as otherwise provided in paragraph (a) and
44 subsection 7, if a person or governmental entity provides a
45 description of the information requested and its proposed use and



1 signs an affidavit to that effect, the Director may release any
2 personal information, except a photograph, from a file or record
3 relating to a driver's license, identification card, or title or
4 registration of a vehicle for use:

5 (a) By any governmental entity, including, but not limited to,
6 any court or law enforcement agency, in carrying out its functions,
7 or any person acting on behalf of a federal, state or local
8 governmental agency in carrying out its functions. The personal
9 information may include a photograph from a file or record relating
10 to a driver's license, identification card, or title or registration of a
11 vehicle.

12 (b) In connection with any civil, criminal, administrative or
13 arbitration proceeding before any federal or state court, regulatory
14 body, board, commission or agency, including, but not limited to,
15 use for service of process, investigation in anticipation of litigation,
16 and execution or enforcement of judgments and orders, or pursuant
17 to an order of a federal or state court.

18 (c) In connection with matters relating to:

- 19 (1) The safety of drivers of motor vehicles;
20 (2) Safety and thefts of motor vehicles;
21 (3) Emissions from motor vehicles;
22 (4) Alterations of products related to motor vehicles;
23 (5) An advisory notice relating to a motor vehicle or the
24 recall of a motor vehicle;
25 (6) Monitoring the performance of motor vehicles;
26 (7) Parts or accessories of motor vehicles;
27 (8) Dealers of motor vehicles; or
28 (9) Removal of nonowner records from the original records
29 of motor vehicle manufacturers.

30 (d) By any insurer, self-insurer or organization that provides
31 assistance or support to an insurer or self-insurer or its agents,
32 employees or contractors, in connection with activities relating to
33 the rating, underwriting or investigation of claims or the prevention
34 of fraud.

35 (e) In providing notice to the owners of vehicles that have been
36 towed, repossessed or impounded.

37 (f) By an employer or its agent or insurer to obtain or verify
38 information relating to a holder of a commercial driver's license
39 who is employed by or has applied for employment with the
40 employer.

41 (g) By a private investigator, private patrol officer or security
42 consultant who is licensed pursuant to chapter 648 of NRS, for any
43 use permitted pursuant to this section.

44 (h) By a reporter or editorial employee who is employed by or
45 affiliated with any newspaper, press association or commercially



1 operated, federally licensed radio or television station for a
2 journalistic purpose. The Department may not make any inquiries
3 regarding the use of or reason for the information requested other
4 than whether the information will be used for a journalistic purpose.

5 (i) In connection with an investigation conducted pursuant to
6 NRS 253.0415 or 253.220.

7 (j) In activities relating to research and the production of
8 statistical reports, if the personal information will not be published
9 or otherwise redisclosed, or used to contact any person.

10 (k) In the bulk distribution of surveys, marketing material or
11 solicitations, if the Director has adopted policies and procedures to
12 ensure that:

13 (1) The information will be used or sold only for use in the
14 bulk distribution of surveys, marketing material or solicitations;

15 (2) Each person about whom the information is requested has
16 clearly been provided with an opportunity to authorize such a use;
17 and

18 (3) If the person about whom the information is requested
19 does not authorize such a use, the bulk distribution will not be
20 directed toward that person.

21 7. Except as otherwise provided in paragraph (j) of subsection
22 6, a person who requests and receives personal information may sell
23 or disclose that information only for a use permitted pursuant to
24 subsection 6. Such a person shall keep and maintain for 5 years a
25 record of:

26 (a) Each person to whom the information is provided; and

27 (b) The purpose for which that person will use the information.

28 ➔ The record must be made available for examination by the
29 Department at all reasonable times upon request.

30 8. Except as otherwise provided in subsection 2, the Director
31 may deny any use of the files and records if the Director reasonably
32 believes that the information taken may be used for an unwarranted
33 invasion of a particular person's privacy.

34 9. Except as otherwise provided in NRS 485.316, the Director
35 shall not allow any person to make use of information retrieved
36 from the system created pursuant to NRS 485.313 for a private
37 purpose and shall not in any other way release any information
38 retrieved from that system.

39 10. *The Director shall not release any information relating to*
40 *legal presence from a file or record relating to a request for or the*
41 *issuance of a license, identification card or title or registration of a*
42 *vehicle to any person or to any federal, state or local governmental*
43 *entity.*

44 11. The Director shall adopt such regulations as the Director
45 deems necessary to carry out the purposes of this section. In



1 addition, the Director shall, by regulation, establish a procedure
2 whereby a person who is requesting personal information may
3 establish an account with the Department to facilitate the person's
4 ability to request information electronically or by written request if
5 the person has submitted to the Department proof of employment or
6 licensure, as applicable, and a signed and notarized affidavit
7 acknowledging that the person:

8 (a) Has read and fully understands the current laws and
9 regulations regarding the manner in which information from the
10 Department's files and records may be obtained and the limited uses
11 which are permitted;

12 (b) Understands that any sale or disclosure of information so
13 obtained must be in accordance with the provisions of this section;

14 (c) Understands that a record will be maintained by the
15 Department of any information he or she requests; and

16 (d) Understands that a violation of the provisions of this section
17 is a criminal offense.

18 ~~11-1~~ **12.** It is unlawful for any person to:

19 (a) Make a false representation to obtain any information from
20 the files or records of the Department.

21 (b) Knowingly obtain or disclose any information from the files
22 or records of the Department for any use not permitted by the
23 provisions of this chapter.

24 ~~12-2~~ **13.** As used in this section:

25 (a) *"Information relating to legal presence" means*
26 *information that may reveal whether a person is legally present in*
27 *the United States, including, without limitation, whether the*
28 *driver's license that a person possesses is a driving privilege card,*
29 *whether the person applied for a driver's license pursuant to NRS*
30 *483.290 or section 5 of this act and the documentation used to*
31 *prove name, age and residence that was provided by the person*
32 *with his or her application for a driver's license.*

33 (b) "Personal information" means information that reveals the
34 identity of a person, including, without limitation, his or her
35 photograph, social security number, *individual taxpayer*
36 *identification number*, driver's license number, identification card
37 number, name, address, telephone number or information regarding
38 a medical condition or disability. The term does not include the zip
39 code of a person when separate from his or her full address,
40 information regarding vehicular accidents or driving violations in
41 which he or she has been involved or other information otherwise
42 affecting his or her status as a driver.

44 vehicle as defined in NRS 490.060.



1 **Sec. 2.** Chapter 483 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 3, 4 and 5 of this act.

3 **Sec. 3.** *“Driving privilege card” means a card obtained in*
4 *accordance with section 5 of this act.*

5 **Sec. 4.** 1. *A person who wishes to obtain an instruction*
6 *permit or a driver’s license may apply using the provisions of NRS*
7 *483.290 or section 5 of this act.*

8 2. *A person who wishes to apply for any restricted or limited*
9 *license issued pursuant to this chapter may do so by:*

10 (a) *Submitting an application using the provisions of NRS*
11 *483.290 or section 5 of this act; and*

12 (b) *Fulfilling the requirements for the issuance of the*
13 *restricted or limited license.*

19 *administer those oaths without charge.*

20 (c) *Be accompanied by the required fee.*

21 (d) *State the name, date of birth, sex and residence address of*
22 *the applicant and briefly describe the applicant.*

23 (e) *State whether the applicant has theretofore been licensed*
24 *as a driver, and, if so, when and by what state or country, and*
25 *whether any such license has ever been suspended or revoked, or*
26 *whether an application has ever been refused, and, if so, the date*
27 *of and reason for the suspension, revocation or refusal.*

28 (f) *Include such other information as the Department may*
29 *require to determine the competency and eligibility of the*
30 *applicant.*

31 2. *Every applicant must furnish proof of his or her name and*
32 *age by displaying an original or certified copy of any one of the*
33 *following documents:*

34 (a) *If the applicant was born in the United States, including,*
35 *without limitation, the District of Columbia or any territory of the*
36 *United States:*

37 (1) *A birth certificate issued by a state, a political*
38 *subdivision of a state, the District of Columbia or any territory of*
39 *the United States;*

40 (2) *A driver’s license issued by another state, the District of*
41 *Columbia or any territory of the United States;*

42 (3) *A passport issued by the United States Government;*

43 (4) *A military identification card or military dependent*
44 *identification card issued by any branch of the Armed Forces of*
45 *the United States;*



1 (5) *For persons who served in any branch of the Armed*
2 *Forces of the United States, a report of separation;*

3 (6) *A Certificate of Degree of Indian Blood issued by the*
4 *United States Government; or*

5 (7) *Such other documentation as specified by the*
6 *Department by regulation; or*

7 (b) *If the applicant was born outside the United States:*

8 (1) *A Certificate of Citizenship, Certificate of*
9 *Naturalization, Permanent Resident Card or Temporary Resident*
10 *Card issued by the United States Citizenship and Immigration*
11 *Services of the Department of Homeland Security;*

12 (2) *A Consular Report of Birth Abroad issued by the*
13 *Department of State;*

14 (3) *A driver's license issued by another state, the District of*
15 *Columbia or any territory of the United States;*

16 (4) *A passport issued by the United States Government;*

17 (5) *A passport or birth certificate issued by a foreign*
18 *government;*

19 (6) *A consular identification card issued by the*
20 *Government of Mexico or a document issued by another*
21 *government that the Department determines is substantially*
22 *similar; or*

23 (7) *Any other proof acceptable to the Department.*

24 ↪ *No document which is written in a language other than English*
25 *may be accepted by the Department pursuant to this subsection*
26 *unless it is accompanied by a verified translation of the document*
27 *in the English language.*

28 3. *Every applicant must prove his or her residence in this*
29 *State by displaying an original or certified copy of any two of the*
30 *following documents:*

31 (a) *A receipt from the rent or lease of a residence located in*
32 *this State;*

33 (b) *A record from a public utility for a service address located*
34 *in this State which is dated within the previous 60 days;*

35 (c) *A bank or credit card statement indicating a residential*
36 *address located in this State which is dated within the previous 60*
37 *days;*

38 (d) *A stub from an employment check indicating a residential*
39 *address located in this State;*

40 (e) *A document issued by an insurance company or its agent,*
41 *including, without limitation, an insurance card, binder or bill,*
42 *indicating a residential address located in this State;*

43 (f) *A record, receipt of bill from a medical provider indicating*
44 *a residential address located in this State; or*



1 (g) Any other document as prescribed by the Department by
2 regulation.

3 4. Every applicant:

4 (a) Who has been issued a social security number must furnish
5 proof of his or her social security number by displaying:

6 (1) An original card issued to the applicant by the Social
7 Security Administration bearing the social security number of the
8 applicant; or

9 (2) Other proof acceptable to the Department, including,
10 without limitation, records of employment or federal income tax
11 returns.

12 (b) Who has not been issued a social security number must
13 furnish proof of his or her individual taxpayer identification
14 number by displaying:

15 (1) An original document issued to the applicant by the
16 Internal Revenue Service bearing the individual taxpayer
17 identification number of the applicant; or

18 (2) Other proof acceptable to the Department, including,
19 without limitation, records of employment or federal income tax
20 returns.

21 5. Except as otherwise provided in subsection 6, a driving
22 privilege card or instruction permit obtained in accordance with
23 this section must:

24 (a) Contain the same information as prescribed for a driver's
25 license pursuant to NRS 483.340 and any regulations adopted
26 pursuant thereto;

27 (b) Be of the same design as a driver's license; and

28 (c) Be numbered from the same sequence of numbers as a
29 driver's license.

30 6. Pursuant to section 202(d)(11) of the Real ID Act of 2005,
31 Public Law 109-13, Division B, Title II, 119 Stat. 302, 312-15, 49
32 U.S.C. § 30301 note, a driving privilege card or instruction permit
33 obtained in accordance with this section:

34 (a) In addition to the information required pursuant to
35 subsection 5, must include the statement "Not for Federal ID
36 Purposes" on its face, using the same font as the other
37 information contained on the face of the card and printed in type
38 that is not larger than the smallest type used for the other
39 information on the face of the card; and

40 (b) Must be imprinted with a symbol resembling a globe that is
41 no larger than the symbol or other indicator used pursuant to NRS
42 483.340 to indicate that a person wishes to be a donor of all or
43 part of his or her body.

44 7. Notwithstanding the provisions of NRS 483.380, every
45 driving privilege card expires on the holder's birthday next nearest



1 *the date of issuance or renewal. Any applicant whose date of birth*
2 *was on February 29 in a leap year is, for the purposes of this*
3 *section, NRS 483.010 to 483.630, inclusive, and sections 3 and 4 of*
4 *this act, considered to have the anniversary of the holder's birth*
5 *fall on February 28. Every driving privilege card is renewable at*
6 *any time before its expiration upon application and payment of the*
7 *required fee. The Department may, by regulation, defer the*
8 *expiration of the driving privilege card of a person who is on*
9 *active duty in the Armed Forces of the United States upon such*
10 *terms and conditions as it may prescribe. The Department may*
11 *similarly defer the expiration of the driving privilege card of the*
12 *spouse or dependent son or daughter of that person if the spouse*
13 *or child is residing with the person.*

14 **8.** *A driving privilege card shall not be used to determine*
15 *eligibility for any benefits, licenses or services issued or provided*
16 *by this State or its political subdivisions.*

17 **9.** *Except as otherwise provided in this section or by specific*
18 *statute, any provision of this title that applies to drivers' licenses*
19 *shall be deemed to apply to a driving privilege card and an*
20 *instruction permit obtained in accordance with this section.*

21 **Sec. 6.** NRS 483.015 is hereby amended to read as follows:

22 483.015 Except as otherwise provided in NRS 483.330, the
23 provisions of NRS 483.010 to 483.630, inclusive, *and sections 3, 4*
24 *and 5 of this act* apply only with respect to noncommercial drivers'
25 licenses.

26 **Sec. 7.** NRS 483.020 is hereby amended to read as follows:

27 483.020 As used in NRS 483.010 to 483.630, inclusive, *and*
28 *sections 3, 4 and 5 of this act*, unless the context otherwise requires,
29 the words and terms defined in NRS 483.030 to 483.190, inclusive,
30 *and section 3 of this act* have the meanings ascribed to them in
31 those sections.

32 **Sec. 8.** NRS 483.083 is hereby amended to read as follows:

33 483.083 "License" means any driver's license or permit to
34 operate a vehicle issued under or granted by the laws of this State,

6 principal residence and mailing address, if different from the
7 address of principal residence, of the applicant and briefly describe

10 driver, and, if so, when and by what state or country, and whether
11 any such license has ever been suspended or revoked, or whether an
12 application has ever been refused, and, if so, the date of and reason
13 for the suspension, revocation or refusal.

14 (f) Include such other information as the Department may
15 require to determine the competency and eligibility of the applicant.

16 2. Every applicant must furnish proof of his or her full legal
17 name and age by displaying an original or certified copy of the
18 required documents as prescribed by regulation.

19 3. The Department shall adopt regulations prescribing the
20 documents an applicant may use to furnish proof of his or her full
21 legal name and age to the Department.

22 4. At the time of applying for a driver's license, an applicant
23 may, if eligible, register to vote pursuant to NRS 293.524.

24 5. Every applicant who has been assigned a social security
25 number must furnish proof of his or her social security number by
26 displaying:

27 (a) An original card issued to the applicant by the Social
28 Security Administration bearing the social security number of the
29 applicant; or

30 (b) Other proof acceptable to the Department, including, without
31 limitation, records of employment or federal income tax returns.

32 6. The Department may refuse to accept a driver's license
33 issued by another state, the District of Columbia or any territory of
34 the United States if the Department determines that the other state,
35 the District of Columbia or the territory of the United States has less
36 stringent standards than the State of Nevada for the issuance of a
37 driver's license.

38 7. With respect to any document presented by a person who
39 was born outside of the United States to prove his or her full legal
40 name and age, the Department:

41 (a) May, if the document has expired, refuse to accept the
42 document or refuse to issue a driver's license to the person
43 presenting the document, or both; and

44 (b) Shall issue to the person presenting the document a driver's
45 license that is valid only during the time the applicant is authorized



1 to stay in the United States, or if there is no definite end to the time
2 the applicant is authorized to stay, the driver's license is valid for 1
3 year beginning on the date of issuance.

4 8. The Administrator shall adopt regulations setting forth
5 criteria pursuant to which the Department will issue or refuse to
6 issue a driver's license in accordance with this section to a person
7 who is a citizen of any state, the District of Columbia, any territory
8 of the United States or a foreign country. The criteria pursuant to
9 which the Department shall issue or refuse to issue a driver's license
10 to a citizen of a foreign country must be based upon the purpose for
11 which that person is present within the United States.

12 9. Notwithstanding any other provision of this section, the
13 Department shall not accept a consular identification card as proof
14 of the age or identity of an applicant for an instruction permit or for
15 a driver's license. As used in this subsection, "consular
16 identification card" has the meaning ascribed to it in NRS 232.006.

17 **Sec. 10.** NRS 483.292 is hereby amended to read as follows:

18 483.292 1. When a person applies to the Department for an
19 instruction permit or driver's license pursuant to NRS 483.290 **H or**
20 **section 5 of this act**, the Department shall inquire whether the
21 person desires to declare that he or she is a veteran of the Armed
22 Forces of the United States.

23 2. If the person desires to declare pursuant to subsection 1 that
24 he or she is a veteran of the Armed Forces of the United States, the
25 person shall provide evidence satisfactory to the Department that he
26 or she has been honorably discharged from the Armed Forces of the
27 United States.

28 3. If the person declares pursuant to subsection 1 that he or she
29 is a veteran of the Armed Forces of the United States, the
30 Department shall count the declaration and maintain it only
31 numerically in a record kept by the Department for that purpose.

32 4. The Department shall, at least once each quarter:

33 (a) Compile the aggregate number of persons who have, during
34 the immediately preceding quarter, declared pursuant to subsection
35 1 that they are veterans of the Armed Forces of the United States;
36 and

37 (b) Transmit that number to the Office of Veterans Services to
38 be used for statistical purposes.

39 **Sec. 11.** NRS 483.620 is hereby amended to read as follows:

40 483.620 It is a misdemeanor for any person to violate any of
41 the provisions of NRS 483.010 to 483.630, inclusive, **and sections**
42 **3, 4 and 5 of this act**, unless such violation is, by NRS 483.010 to
43 483.630, inclusive, **and sections 3, 4 and 5 of this act**, or other law
44 of this State, declared to be a felony.



- 1 **Sec. 12.** This act becomes effective:
2 1. Upon passage and approval for the purpose of adopting
3 regulations and performing any other preparatory administrative
4 tasks that are necessary to carry out the provisions of this act; and
5 2. On January 1, 2014, for all other purposes.
