## INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Commerce and Labor:

Assembly Bill No. 204—AN ACT relating to appraisers of real estate; restricting the use in an appraisal of information relating to the sale of certain distressed properties; requiring an appraiser to maintain an office in this State; and providing other matters properly relating thereto.

Assemblyman Bobzien moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By the Committee on Education:

Assembly Bill No. 205—AN ACT relating to education; requiring the sponsor of a charter school to develop a performance framework for the charter school and incorporate that performance framework into the charter contract; revising the procedure for reviewing an application to form a charter school; setting forth requirements for the execution and renewal of charter contracts; setting forth the grounds for termination of a charter contract; revising provisions relating to the enrollment of pupils in charter

schools; making various other changes relating to charter schools; and providing other matters properly relating thereto.

Assemblyman Elliot Anderson moved that the bill be referred to the Committee on Education.

Motion carried.

By Assemblyman Sprinkle:

Assembly Bill No. 206—AN ACT relating to industrial insurance; providing that volunteer members of a county search and rescue organization shall be deemed to be employees of the county at a wage specified by statute for certain purposes relating to industrial insurance; and providing other matters properly relating thereto.

Assemblyman Sprinkle moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblyman Ohrenschall:

Assembly Bill No. 207—AN ACT relating to juveniles; revising the definition of an act of domestic violence as it relates to a person who is less than 18 years of age; establishing a maximum period of time for which a juvenile court may order an adult who has been placed on probation by the juvenile court or released on parole to be placed in county jail for a violation of probation or parole; and providing other matters properly relating thereto.

Assemblyman Ohrenschall moved that the bill be referred to the Committee on Judiciary.

Motion carried.
