INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Munford, Healey, Carlton, Frierson, Paul Anderson, Diaz, Fiore, Grady, Horne, Kirner, Livermore, Neal, and Swank; Senators Atkinson, Gustavson, Settelmeyer, and Spearman:

Assembly Bill No. 208—AN ACT relating to taxation; prohibiting the Department of Taxation from considering the provision of meals by employers to their employees to constitute sales to which sales taxes apply; and providing other matters properly relating thereto.

Assemblyman Munford moved that the bill be referred to the Committee on Taxation.

By Assemblymen Aizley and Ohrenschall; Senator Segerblom:

Assembly Bill No. 209—AN ACT relating to dairy products; revising certain provisions governing the sale of milk and milk products to be consistent with federal law; providing that raw milk certified by the county milk commission of the county in which the raw milk is produced may be sold anywhere in this State; and providing other matters properly relating thereto.

Assemblyman Aizley moved that the bill be referred to the Committee on Health and Human Services.

By the Committee on Education:

Assembly Bill No. 210—AN ACT relating to education; requiring an individualized education program team to consider certain factors when developing an individualized education program for a pupil with a hearing impairment; requiring that minimum standards for the special education of pupils with hearing impairments prescribed by the State Board of Education

include certain provisions; and providing other matters properly relating thereto.

Assemblyman Elliot Anderson moved that the bill be referred to the Committee on Education.

By Assemblymen Hansen, Wheeler, Ellison, Hambrick, Paul Anderson, Grady, Kirner, Livermore, and Stewart; Senator Gustavson:

Assembly Bill No. 211—AN ACT relating to public works; revising provisions relating to the requirement for the payment of prevailing wages on certain contracts for public works; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Government Affairs.

By Assemblymen Hansen, Hambrick, Paul Anderson, Ellison, Grady, Kirner, Livermore, Stewart, and Wheeler; Senator Gustavson:

Assembly Bill No. 212—AN ACT relating to correctional institutions; prohibiting the possession of portable telecommunications devices by certain prisoners; providing penalties; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Judiciary.

By Assemblyman Bobzien:

Assembly Bill No. 213—AN ACT relating to service contracts; allowing a provider to qualify for the issuance of a certificate of registration by maintaining a reserve account and depositing certain security with the Commissioner of Insurance; and providing other matters properly relating thereto.

Assemblyman Bobzien moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblymen Eisen and Carrillo:

Assembly Bill No. 214—AN ACT relating to contractors; requiring the State Contractors' Board to adopt regulations providing a classification of licensure for persons who install or maintain building shell insulation or thermal system insulation; requiring such persons to be licensed in that classification; and providing other matters properly relating thereto.

Assemblyman Eisen moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblyman Ohrenschall:

Assembly Bill No. 215—AN ACT relating to graywater; requiring the State Board of Health to adopt regulations concerning systems for the collection and application of graywater for a single-family residence; providing that state and local governmental agencies must not require a permit for or prohibit the collection and application of graywater for a single-family residence that meets certain requirements; and providing other matters properly relating thereto.

Assemblyman Ohrenschall moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Assemblymen Hansen, Wheeler, Ellison, Hambrick, Fiore, Paul Anderson, Grady, Livermore, and Stewart; Senator Gustavson:

Assembly Bill No. 216—AN ACT relating to elections; requiring registered voters to provide photographic identification to vote in person; requiring county clerks to issue photographic identification under certain circumstances; revising provisions concerning provisional ballots; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Legislative Operations and Elections.

Motion carried.

By the Committee on Judiciary:

Assembly Bill No. 217—AN ACT relating to protection of children; requiring the department of juvenile justice services of certain larger counties and agencies which provide child welfare services to obtain a background investigation of the criminal history of applicants for employment; requiring such a department or agency to terminate or deny employment of certain persons based on the results of an investigation of the person's criminal history; authorizing such a department or agency to terminate or deny employment if certain criminal charges are pending against an employee or applicant for employment; and providing other matters properly relating thereto.

Assemblyman Frierson moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Government Affairs:

Assembly Bill No. 218—AN ACT relating to public works; defining the term “bona fide fringe benefit” for certain provisions applicable to the payment of wages for public works; revising the requirements pursuant to which a contractor or subcontractor engaged on a public work may discharge his or her obligation to pay prevailing wages to workers; and providing other matters properly relating thereto.

Assemblywoman Benitez-Thompson moved that the bill be referred to the Committee on Government Affairs.
