INTRODUCTION, FIRST READING AND REFERENCE

By Assemblywoman Flores:

Assembly Bill No. 219—AN ACT relating to civil actions; providing that damages for which a person or corporation is liable to another person in certain actions for personal injury must not be reduced by any amount payable or otherwise applied as a benefit to the person injured; and providing other matters properly relating thereto.

Assemblywoman Flores moved that the bill be referred to the Committee on Judiciary.

By Assemblyman Daly:

Assembly Bill No. 220—AN ACT relating to credit cards; prohibiting certain payees from applying a surcharge to the purchase by credit card of any goods or services; and providing other matters properly relating thereto.

Assemblyman Daly moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblymen Dondero Loop, Kirkpatrick, and Eisen:

Assembly Bill No. 221—AN ACT relating to public welfare; requiring the Director of the Department of Health and Human Services to issue a request for information to determine the availability, cost and appropriateness of certain measures to revise the manner in which payments are reviewed and made to providers under Medicaid and the Children's Health Insurance Program; requiring the Director to enter into any appropriate contracts; and providing other matters properly related thereto.

Assemblywoman Dondero Loop moved that the bill be referred to the Committee on Health and Human Services.

By Assemblymen Diaz, Bustamante Adams, Flores, Neal, Carrillo, and Benitez-Thompson; Senators Denis, Kihuen, and Segerblom:

Assembly Bill No. 222—AN ACT relating to education; requiring the Board of Trustees of the Clark County School District and the Board of Trustees of the Washoe County School District to adopt pilot programs for the establishment of reading skills development centers; making appropriations for the establishment, operation and support of reading skills development centers; and providing other matters properly relating thereto.

Assemblywoman Diaz moved that the bill be referred to the Concurrent Committees on Education and Ways and Means.

By Assemblywoman Kirkpatrick:

Assembly Bill No. 223—AN ACT relating to constables; providing that a constable may perform certain evictions only in his or her township; revising provisions governing the powers and duties of a constable with respect to the service of process and the execution of writs and warrants; revising provisions governing the appointment of deputy constables and the clerical and operational staff of a constable; clarifying that a constable may issue a citation for a violation of certain laws governing the registration of motor vehicles only if the motor vehicle is located in his or her township; revising various other provisions governing constables; and providing other matters properly relating thereto.

Assemblyman Horne moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 224—AN ACT relating to education; requiring that the automated system of accountability information for Nevada established and maintained by the Department of Education include a unique identifier for each pupil whose parent or guardian is a member of the Armed Forces of the United States, a reserve component thereof or the National Guard, or has served as such and was discharged or released on or after September 11, 2001; and providing other matters properly relating thereto.

Assemblyman Elliot Anderson moved that the bill be referred to the Committee on Education.
