INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Stewart, Grady, Hardy and Hickey:

Assembly Bill No. 225—AN ACT relating to business brokers; revising the definition of the term "business broker"; limiting the application of the term to the performance of certain acts; and providing other matters properly relating thereto.

Assemblyman Stewart moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblywoman Bustamante Adams:

Assembly Bill No. 226—AN ACT relating to insurance; requiring an insurer to request certain information from its insureds, annuity holders and

retained asset account holders; requiring an insurer to perform a comparison of the insurer's life insurance policies, annuities and retained asset accounts against the Death Master File from the Social Security Administration or other approved database; requiring an insurer to perform certain actions if a comparison with the Death Master File results in a match with an insured, annuity holder or retained asset account holder; and providing other matters properly relating thereto.

Assemblywoman Bustamante Adams moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 227—AN ACT relating to public lands; creating the Nevada Land Management Implementation Committee to conduct a study addressing the transfer of public lands in Nevada from the Federal Government to the State of Nevada; and providing other matters properly relating thereto.

Assemblyman Ellison moved that the bill be referred to the Committee on Legislative Operations and Elections.

Assembly Bill No. 228—AN ACT relating to health care; authorizing a provider of health care who is licensed or certified in this State or in another state or territory of the United States to provide voluntary health care service in this State in association with a sponsoring organization; establishing certain restrictions on the provision of voluntary health care service by a provider of health care; requiring a sponsoring organization to register and file certain reports with the Health Division of the Department of Health and Human Services; requiring each contract of professional liability insurance offered in this State to include certain coverage relating to the provision of voluntary health care service; and providing other matters properly relating thereto.

Assemblyman Grady moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 230—AN ACT relating to education; requiring the board of trustees of each school district to establish a comprehensive, age-appropriate and medically accurate course of instruction in sex education; requiring the Council to Establish Academic Standards for Public Schools to establish standards of content and performance for a course of instruction in sex education as part of a course of study in health; and providing other matters properly relating thereto.

Assemblyman Bobzien moved that the bill be referred to the Committee on Education.

By Assemblymen Oscarson, Ellison, Hardy, and Wheeler; Senators Goicoechea and Settlemeyer:

Assembly Bill No. 231—AN ACT relating to local governing bodies; providing for the filling of vacancies in the membership of certain local governing bodies; and providing other matters properly relating thereto.

Assemblyman Oscarson moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblymen Oscarson, Ellison, Wheeler, Fiore, Hickey, and Hardy; Senators Goicoechea and Settlemeyer:

Assembly Bill No. 232—AN ACT relating to concealed firearms; removing the prohibition against carrying a concealed firearm; repealing certain provisions relating to permits to carry concealed firearms; and providing other matters properly relating thereto.

Assemblyman Oscarson moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblywoman Flores:

Assembly Bill No. 233—AN ACT relating to genetic marker analysis; authorizing the appeal of an order dismissing a petition for genetic marker analysis; and providing other matters properly relating thereto.

Assemblywoman Flores moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblymen Horne, Frierson, Flores, Eisen, Bustamante Adams, Carlton, Healey, and Pierce; Senators Segerblom, Spearman, Atkinson, and Kihuen:

Assembly Bill No. 234—AN ACT relating to firearms; requiring certain persons to request a background check before transferring a firearm to another person under certain circumstances; prohibiting the possession of certain bullets, projectiles or ammunition; establishing a civil cause of action for injuries arising from the unlawful transfer of a firearm; providing for the imposition and administration of a tax on firearms dealers for the privilege of selling firearms and ammunition to consumers; establishing the Fund for Treatment of Persons with Mental Illness; providing penalties; and providing other matters properly relating thereto.

Assemblyman Horne moved that the bill be referred to the Committee on Judiciary.

Motion carried.
